
HEARING OFFICER ORDER

On April 26, 2012, a telephonic status conference was held. Respondent Zachary Isaac d/b/a Nu Shine Car Wash (NuShine) did not appear. A stipulation and proposal for settlement has been filed and accepted by the Board pertaining to Samuel Johnson.

The complainant stated it is hopeful that it will file a motion for default as to NuShine within the next 14 days. It is again noted that NuShine has yet to file an appearance or answer.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on July 12, 2012, at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation is filed prior to the next status conference as to Johnson, Johnson will not have to appear.

IT IS SO ORDERED.




