

**MOTION FOR EXTENSION OF TIME IN WHICH TO FILE
THE ADMINISTRATIVE RECORD AND FOR LEAVE TO FILE A REDUCED
NUMBER OF COPIES OF THE RECORD**

NOW COMES, Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY, *ex rel.* Lisa Madigan, Attorney General of the State of Illinois, and moves the Pollution Control Board ("Board") for: 1) an extension of time, until October 12, 2012, by which to file the administrative record in this permit appeal; and 2) for leave to file a reduced number of copies of the record for the subject permit appeal. Respondent states the following in support of this motion:

1. On September 17, 2012, the Hearing Officer in this matter issued an order setting a September 28, 2012 deadline by which Respondent was to file the administrative record in this permit appeal.

2. On September 25, 2012, the Illinois Attorney General ("Attorney General"), counsel for the Respondent, received a CD from the Illinois Environmental Protection Agency ("Illinois EPA") which contained the administrative record for this permit appeal. The administrative record consists of approximately 3,000 pages, none of which have been Bates-stamped.

3. Given the Attorney General's technological, financial, and personnel constraints, it will not be possible for this office to fully review and prepare a Bates-stamped administrative record for this permit appeal by the current September 28, 2012 deadline. The Attorney General believes that it will be possible to prepare and file the administrative record by not later than October 12, 2012. The Attorney General has advised Petitioner's counsel of the foregoing and counsel has informed the Attorney General that Petitioner has no objection to extending the time for filing the administrative record until October 12, 2012.

4. Additionally, reproduction of the record in conformity with the Board's regulations would be both time consuming and a strain upon the State's resources. For these reasons, plus the ability to include an electronic copy of the entire record on disc, Respondent requests the Board's permission to allow Respondent to file a reduced number of hard copies of the administrative record.

5. On September 27, 2012, the undersigned telephoned the Clerk of the Board, who indicated that the Board may be agreeable to accepting an original and two hard copies of the administrative record, along with seven additional electronic copies of the administrative record to be provided on CD discs, in lieu of the required original and nine hard copies.


WHEREFORE, on the foregoing grounds and for the foregoing reasons, Respondent respectfully requests:

1. That it be given until October 12, 2012 by which to file the administrative record in this matter; and

2. That it be granted leave to file a reduced number of copies, that being an original, two paper copies and 7 CDs, of the administrative record for this permit appeal.


