HEARING OFFICER ORDER


On October 29, 2012, all parties participated in a telephonic status conference with the hearing officer. Discussions centered on petitioner being unable to locate certain documents that are presumably part of the record but were not filed with the record. Respondent stated that it will search for the alleged missing documents.

It is noted that on October 15, 2012, respondent filed a motion for leave to file a reduced number of copies of the record. At the telephonic status conference, the petitioner stated that it had no objection but would like the missing documents to be forwarded. The respondent's motion was granted and it was given leave to file an original and two (2) copies of the record in this matter, along with three (3) CD copies.

The parties or their legal representatives are directed to participate in a telephonic pre-hearing conference with the hearing officer on November 7, 2012, at 11:30 a.m. The telephonic conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


