**HEARING OFFICER ORDER**


On January 4, 2013, respondent filed an agreed motion to withdraw and re-plead its affirmative defenses. Respondent requested that it be given to January 15, 2013, to re-file its affirmative defenses. Respondent also suggested that the telephonic status conference scheduled for January 10, 2013, be rescheduled.

Respondent's motion is granted to the extent that it may withdraw its affirmative defenses filed on November 1, 2012, and it has until January 15, 2013, to re-plead and re-file its affirmative defenses. The telephonic status conference that was scheduled for January 10, 2013, is hereby cancelled and continued to the date and time noted below.

Finally, it does not appear that respondent has filed its Appearance in the above-captioned matter and is directed to do so on or before January 15, 2013.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on February 14, 2013, at 10:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


