

HEARING OFFICER ORDER

On February 28, 2013, all parties participated in a telephonic status conference with the hearing officer. The complainant stated that a draft stipulation and proposal for settlement (stipulation) is presently being reviewed by the respondents. The parties are optimistic that the stipulation will be filed prior to the next status conference. By agreement, the respondents answers or other pleadings are now due to be filed on or before May 2, 2013.

The parties or their legal representatives are directed to participate in a telephonic pre-hearing conference with the hearing officer on April 4, 2013, at 9:15 a.m. The telephonic conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation is filed prior to the next status conference, the conference will be cancelled without further notice.

IT IS SO ORDERED.




