Subject: NAAQS Identical-in-Substance Proceeding

I understand that IERG was instrumental in the new identical-in-substance mandate that the Board received last August in P.A. 97-945. The mandate relates to adoption of federal National Ambient Air Quality Standards (NAAQSs). We have been assembling a proposal for public comment, which the Board will likely adopt in May and publish in the *Illinois Register* in late May or early June.

We are planning to hold the public hearing required for a SIP revision by section 110 of the federal Clean Air Act. At present, it appears that the hearing will occur the week of June 24, 2013.

Do you wish anyone from IERG listed in the service list for this proceeding or on the notice list? On the service list, your designee should receive all filings in this matter. On the notice list, your designee will receive copies of all Board actions in this matter?

Does your organization intend to participate at the public hearing? If so, please give me any preferences you may have with regard to the timing of a public hearing that will likely occur the week of June 24, 2013.
