
HEARING OFFICER ORDER

On June 12, 2013, all parties participated in a telephonic status conference with the hearing officer. The complainant stated that settlement discussions continue with respondent Midwest Environmental Consulting Services, Inc. (Midwest Environmental) and remain hopeful that a resolution can be achieved. To that end, it was agreed upon by complainant and Midwest Environmental that its answer or other response is now due to be filed on or before July 25, 2013.

Respondent Universal Asbestos Removal, Inc. (Universal Asbestos) stated that it intends to file an answer with a motion for leave to file within the next few days. Universal Asbestos stated that it is hopeful that a settlement can be reached without the necessity of a hearing.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on July 18, 2013, at 9:30 a.m. The telephonic conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




