

**UNOPPOSED MOTION FOR EXTENSION OF TIME**

Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY (Illinois EPA), by and through its attorney, LISA MADIGAN, Attorney General of the State of Illinois, respectfully move the Illinois Pollution Control Board (Board) pursuant to 35 Ill. Adm. Code 101.500(d) for an extension of time to respond to the Motion to Dismiss filed by Dynegy Midwest Generation, Inc. (Dynegy) on June 17, 2013, until July 19, 2013. Dynegy does not oppose this motion. In support of the motion, Respondent Illinois EPA states as follows:

1. On June 17, Dynegy filed a Motion to Dismiss the action;
2. Due to Respondents' counsel's obligations in other pending matters, as well as Respondents' and Respondents' counsel's availability to discuss the response due to vacation and holiday schedules, Respondent Illinois EPA requests an additional 14 days to respond to the Motion to Dismiss, until July 19, 2013.
3. Dynegy does not oppose this motion.
4. Dynegy has also agreed to provide an extension of time to respond to the Motion to Dismiss to the Petitioners until July 19, 2013.

5. Respondent, Illinois EPA, makes this motion in good faith, and not for purposes of delay.

WHEREFORE, Respondent Illinois EPA moves for an extension of time to and including July 19, 2013 to respond to Dynegey's Motion to Dismiss, and for such other relief as the Board may deem appropriate.
