HEARING OFFICER ORDER

On September 12, the hearing officer directed the parties to file a status report by October 15, 2013. However, petitioner has new counsel in this matter, and there may have been some confusion between this docket, and PCB 06-140, involving the same facility. To be clear, the cases are not consolidated, and filings must be made separately for both dockets.

In docket PCB 06-140, assigned to hearing officer Bradley Halloran, petitioner's new counsel filed an appearance, and presumably received Mr. Halloran's order directing the filing of a status report by October 27, 2013.

In docket PCB 97-195, petitioner's counsel did not file a substitute appearance, so it is not clear whether he received the hearing officer order directing the filing of a status report by October 15, 2013. Accordingly, the deadline for the status report for this docket is extended to October 28, 2013, and will be sent to petitioner's new counsel.

If no status report is received for this docket by October 28, 2013, the hearing officer will refer the matter to the Board for dismissal. Again, separate status reports must be filed for both dockets.

There is an open waiver of the statutory decision deadline in this matter.
