LEGAL NOTICE

Notice of Petition by Brickyard Disposal & Recycling, Inc., (hereinafter "Brickyard") for Adjusted Standard before the Illinois Pollution Control Board. On October 9, 2013, Brickyard filed with the Illinois Pollution Control Board (hereinafter "Board") an Amended Adjusted Standard Petition pursuant to Section 28.1 of the Environmental Protection Act and the Board regulation at 35 Ill. Adm. Code 814.402(b)(3) (Docket AS 2013-004). Brickyard is located at 601 Brickyard Road, Danville, Illinois. Brickyard operates a solid waste landfill at this location consisting of two units. Unit 1 no longer receives waste and, in order to achieve effective closure, seeks an adjustment of the compliance boundary, particularly as that relates to the location of groundwater monitoring points. The adjustment is provided for in Section 814.402(b)(3) and seeks an alternative standard, subject to permitting, than that required in 35 Ill. Adm. Code 811.318(b)(3). Any person may cause a public hearing to be held in the above-described adjusted standard proceeding by filing a hearing request with the Board within 21 days after the date of publication of this notice. The hearing request should clearly indicate the docket number for the adjusted standard proceeding, as found in this notice, and must be mailed to the Clerk of the Board, Illinois Pollution Control Board, 100 W. Randolph Street, Suite 11-500, Chicago, Illinois 60601.
