### **JURISDICTION**

This Administrative Citation is issued pursuant to authority vested in the Illinois Environmental Protection Agency by 415 ILCS 5/1 et. seq., specifically 415 ILCS 5/31.1.

### **FACTS**

- 1. The Respondent, Deana Ardrey, is the present owner, occupant and in control and possession of a facility located in the County of Jackson, State of Illinois.
- The Respondent, Paul Smith, is in control and possession and an occupant of a facility located in the County of Jackson, Illinois.
- 3. The facility is an open dump, operating without an Illinois Environmental Protection Agency Operating Permit, and designated with the Site Code # 077 810 5089. The facility is known to the Agency as the Murphysboro/Deana Ardrey site.
- 4. The Respondents have owned, occupied, controlled and/or operated the facility at all relevant times hereto.
- 5. On June 17, 2014, Don Terry, Field Inspector, Jackson County Health Department, inspected the facility. A true and correct copy of the inspection report, along with Mr. Terry's affidavit, are attached and incorporated herein by reference as Exhibit A.

### **VIOLATIONS**

On the basis of Field Inspector Don Terry's direct observation he has determined that the Respondents have caused or allowed open dumping at the above described facility in a manner that resulted in the following violations:

That on June 17, 2014, an inspection of the facility disclosed the following:

- The Respondents have caused or allowed litter at the facility in violation of 415 ILCS
   5/21(p)(1).
- The Respondents have caused or allowed open burning at the facility in violation of 415
   ILCS 5/21(p)(3).
- 3. The Respondents have caused or allowed the deposition of general or clean construction or demolition debris at the facility in violation of 415 ILCS 5/21(p)(7).

### CIVIL PENALTY

Pursuant to Section 42(b)(4-5) of the Act, 415 ILCS 5/42(b)(4-5), Respondents are subject to a civil penalty of One Thousand Five Hundred Dollars (\$1,500.00) for each of the violations identified above, for a total of <u>FOUR THOUSAND FIVE HUNDRED DOLLARS (\$4,500.00)</u>. If Respondents elect not to petition the Illinois Pollution Control Board, the statutory civil penalty specified above shall be due and payable no later than August 15, 2014, unless otherwise provided by order of the Illinois Pollution Control Board.

If Respondents elect to contest this Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1, and if the Illinois Pollution Control Board issues a finding of violation as alleged herein, after an adjudicatory hearing, Respondents shall be assessed the associated hearing costs incurred by the Illinois Environmental Protection Agency and the Illinois Pollution Control Board. Those

hearing costs shall be assessed in addition to the Fifteen Hundred Dollars (\$1,500.00) statutory civil penalty for each violation.

Pursuant to Section 31.1(d)(1) of the Act, 415 ILCS 5/31.1(d)(1), if Respondents fail to petition or elect not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and findings of violation as alleged herein, and shall impose the statutory civil penalty specified above.

When payment is made, checks shall be made payable in equal amounts (50% of total penalty each) to:

- County of Jackson, c/o Jackson County Treasurer, Jackson County Courthouse,
   Murphsyboro, Illinois 62966; and
- (2) Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276.

Respondents shall complete and return the enclosed Remittance Forms with payments to ensure proper documentation of payment. If any civil penalty and/or hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs shall be assessed against the Respondents from the date payment is due up to and including the date that payment is received. The Complainant may either initiate proceedings against either or both Respondents in Circuit Court or other debt collection actions to collect said penalty and/or hearing costs, plus any interest accrued.

## PROCEDURE FOR CONTESTING ADMINISTRATIVE CITATION

You have the right to contest this Citation, pursuant to 415 ILCS 5/31.1. If you elect to contest this Citation, you must file a Petition For Review with the Clerk of the Illinois Pollution Control Board. YOUR PETITION MUST STATE THE REASON(S) YOU BELIEVE THE PRESENT MATTER SHOULD NOT BE ISSUED. IF YOU FAIL TO FILE YOUR PETITION AND STATE THE REASONS THE PRESENT MATER SHOULD NOT BE ISSUED, A DEFAULT ORDER AGAINST YOU WILL BE ENTERED BY THE POLLUTION CONTROL BOARD.

#### **GENERAL REMARKS**

**Background**: On March 12, 2013, this inspector conducted an inspection of the site known as Murphysboro / Deana Ardrey (BOL #077 810 5089). The site is located at 54 Jonesboro Road in Murphysboro, IL and is identified with the Jackson County tax parcel ID # 14-10-353-005. Deana Ardrey is identified as the owner (**Attachment: Page 1**). During the inspection, I spoke with Paul Smith who identified himself as one of the residents of the site. The inspection found the open dumping and open burning of waste was occurring at the site. An Administrative Citation Warning Notice (ACWN) dated March 25, 2013 was sent to both Ms. Ardrey and Mr. Smith. The letter that both Ms. Ardrey and Mr. Smith received stated in #1 of the Corrective Actions: "Cease all open dumping immediately. Do not dispose of any of the waste by open burning."

During the stated date and time, I conducted an inspection of the site listed above. This inspection was made as a follow up to observations this inspector made from Illinois Route 127, a public road way (Site Sketch: V). Weather conditions at the time of the inspection were: Partly cloudy with gusting winds and a temperature of approximately 88°F. I was accompanied on this inspection by Henry Mulder of the Jackson County Health Department.

I was traveling north on Illinois Route 127 when I looked to the northeast in the direction of a site known to this office (see Background above). From Illinois Route 127, I observed yellow flames coming from what appeared to be a barrel and from a site on the ground near the barrel. I turned onto Jonesboro Road and traveled toward the area where I had observed the flames.

I arrived at the site and parked my vehicle on the edge of the roadway. I observed a barrel with flames coming out of the top and a waste pile next to the metal barrel that was on fire. I observed 8 to 10 individuals in the yard, one who I identified as Paul Smith. I exited the vehicle and walked south toward the area of open burning. Mr. Smith came up to me and said he didn't know he couldn't burn and the burning was an accident. I stated to Mr. Smith that I had told him in the past on several occasions that he could not dispose of his waste by open burning.

At the area where the open burning was occurring, I observed: 1) a waste pile consisting of ash, carpeting and other materials that were on fire (Photos #1 & #4, Site Sketch), 2) a metal barrel containing ash and waste which was on fire (Photos #2, #4 & #5, Site Sketch) and 3) a plastic barrel containing a bag filled with garbage, a glass bottle and metal wire (Photos #3 & #5, Site Sketch). A female adult asked if the fire should be put out. I stated yes.

I walked back to my vehicle and observed to the northwest another waste pile (Photo #6, Site Sketch). The waste in this pile consisted of, but was not limited to: dimensional lumber, plastic bags and cardboard.

The total volume of waste observed was approximately 6 cubic yards.

My inspection ended at approximately 12:01 p.m.

### Violations Observed:

<u>Item #1(9)(a)</u>: Cause, threaten or allow air pollution in Illinois; <u>Item #2(9)(c)</u>: Cause or allow open burning; <u>Item #8(21)(p)(3)</u>: Cause or allow the open dumping of any waste in a manner which results in any of the following occurrences at the dump site: (3) Open Burning: During the inspection the open dumping of waste that resulted in open burning and which caused, threatened or allowed air pollution in Illinois was observed.

<u>Item #5(21)(a)</u>: Cause or allow open dumping; <u>Item #8(21)(p)(1 & 7)</u>: Cause or allow the open dumping of any waste in a manner which results in any of the following occurrences at the dump site: (1) Litter and (7) Deposition of general construction or demolition debris; or clean construction or demolition debris: During the inspection, the open dumping of waste that resulted in litter and the deposition of general construction or demolition debris was observed.


