MOTION TO STRIKE

NOW COME Petitioners, AMEREN ENERGY GENERATING COMPANY (“Ameren Energy”), ELECTRIC ENERGY, INC., and MIDWEST ELECTRIC POWER, INC. (“Petitioners”), by and through its attorneys, SCHIFF HARDIN LLP, and hereby request that the Illinois Pollution Control Board (“Board”) strike AMEREN ENERGY GENERATING COMPANY from this matter. In support of this Motion, Ameren Energy states as follows:

1. On April 23, 2009, Petitioners filed a Petition for Appeal (“Petition”) of the Clean Air Act Permit Program renewal permit issued to it by the Illinois Environmental Protection Agency on March 19, 2009.
2. Electric Energy, Inc. owns 100% of Midwest Electric Power, Inc., which owns and operates the Midwest Electric Power, Inc. station. Ameren Energy Generating Company has no role in the operation of the Midwest Electric Power, Inc. station and has no role in the current Title V Permit Appeal.

WHEREFORE, Petitioners, AMEREN ENERGY GENERATING COMPANY, ELECTRIC ENERGY, INC., and MIDWEST ELECTRIC POWER, INC. move the Illinois

Pollution Control Board to grant this Motion to Strike the Petitioner Ameren Energy Generating Company from this case.


