INTRODUCTION

This report covers the activity of the Pollution Control Board during the period from July 1, 1975 through June 30, 1976.

The Environmental Protection Act of 1970 established three separate state agencies in a unique system to provide for the regulatory, quasi-judicial, enforcement, research, and support activity, necessary for the protection of the environment in Illinois. Responsibility for all of the various environmental media, namely air, water, land, water supply and noise, are under the jurisdiction and control of these agencies, except to the extent that state control has been pre-empted by Federal Statute.

The Pollution Control Board, composed of five members, employs a staff of 18 full-time personnel and engages per diem hearing officers to preside at hearings under the Act. Hearing officers are assigned from a panel of approximately 105 Illinois lawyers who have requested such assignment and been found to be qualified by the Board. The Board adopts and modifies regulations; decides enforcement, variance and permit appeal cases; and gives environmental approval to permits for constructions in the Illinois waters of Lake Michigan.

The Illinois Environmental Protection Agency has a staff of approximately 600 persons. The Agency regularly monitors actual and potential sources of pollution; issues development, construction and operating permits; administers State and Federal anti-pollution construction grants programs; issues tax exemption certifications for pollution control equipment; develops plans for the attainment of air and water quality in cooperation with local, state and federal agencies and officers; and, is the complainant in the majority of the enforcement cases filed with the Board. By statute the Agency is the respondent in all variance cases, investigates all variance petitions and files with the Board their recommendation for the disposition of the petition.

The third agency created by the Act is the Institute for Environmental Quality, which has a staff of 14. The Institute conducts applied research into environmental problems of Illinois by utilizing, under contract, the services of scientific, technical and engineering specialists, the research capabilities of

institutions of higher education, and the state technical surveys. The Institute has the responsibility for the evaluation of the economic costs and benefits of environmental regulations and is required to prepare a comprehensive and detailed economic impact study on all proposed regulations for consideration by the Board and the public at open hearings prior to adoption. The Institute also provides expert guidance to the Board and Agency in the formulation of regulations and has a special mandate to make surveys and recommendations toward the development of regional solid waste disposal programs and to expedite development of systems for the re-cycling of solid waste.

BOARD PERSONNEL

Two new Board Members were appointed in the past fiscal year. Mr. James L. Young of Springfield was named by the Governor in October 1975. Mr. Young is a lawyer and engineer and formerly headed the enforcement services section of the water pollution control division of the Illinois Environmental Protection Agency. Dr. Donald P. Satchell of Carbondale, a professor in the School of Agriculture at Southern Illinois University was named in December 1975. Dr. Satchell's expertise is in agronomy and soils. The two appointees replaced Mr. Donald A. Henss of Moline and Dr. Russell Odell of Champaign who each decided not to ask for reappointment.

In June 1976 four members of the Board including Mr. Young, Dr. Satchell, Mr. Irvin G. Goodman and Chairman Jacob D. Dumelle, were confirmed by the Illinois Senate; the latter two to full 3-year terms ending June 30, 1979.

REGULATIONS

Fiscal Year 1976 saw a marked decline in Board final action upon regulatory proposals due to enactment of Public Act 79-790 (Senate Bill 805) which amended Section 6 and 27 of the Act to require comprehensive economic impact studies and hearings prior to Board adoption of any proposed regulation. The requirement became effective October 1, 1975 and at the end of Fiscal Year 1976, no economic impact studies had been released to the Board by the Institute for Environmental Quality. Consequently, from October 1, 1975 to June 30, 1976 the Board was not able to adopt any regulatory proposals regardless of whether the proposals would have created new requirements or delayed or loosened existing standards. The sole exception was R75-4, Air Episode Amendments, which, due to its public health emergency nature, as determined by the Board, was not required to have the economic impact study and hearings until after its adoption.

On July 10, 1975 the Board adopted R72-7, amending the Air Pollution Regulations to include an ambient air quality standard for Sulfur Oxides. Due to delays in federal funding of sewage treatment plants and new project eligibility criteria the Board adopted R74-14, amending Rule 409 of the Water Regulations to extend effluent deadlines to July 1, 1977 for discharges eligible for those federal funds. Also in July of 1975 the Board dismissed R73-16 concluding that the record was not developed sufficiently to support the proposed amendment to Air Regulation 203(d)(6)(B) regarding coke oven facilities.

On August 28, 1975 the Board, upon motion of the proponent Environmental Protection Agency, dismissed R74-5 without prejudice. The proposal would have established an ambient air quality standard for total mercury, but was withdrawn for further study. At that same meeting the Board also dismissed the proposed R74-14, Motor Racing Noise Regulations, which was aimed at exempting motor racing from existing numerical standards. However, the Board did extend the compliance date for those sources to February 10, 1976 and consolidated R74-14 into R75-11 for further hearings.

In R75-2, Water Quality and Effluent Standards Amendments, Cooling Lakes, the Board adopted a case-by-case method to determine temperature effluent standards for artificial cooling lakes used by steam-electric generating plants.

On September 4, 1975 the Board adopted R74-13, amending Air Regulation 204(f)(1) to exempt hydrogen sulfide flares from SO₂ standards of that Rule. At its September 29, 1975 meeting, the Board acted upon four proposals. The Board dismissed R71-15, Plant Nutrients, finding the regulation of nitrogen fertilizer as a means to control nitrates in Illinois streams was not justified at that time. The Board adopted a new Rule 604 of the Water Pollution Regulations, designated R71-19, Sewer Connection Bans. The new rule requires the Agency to compile and publish lists of all sewage treatment plants which are, or may soon be, operating at such capacity as to cause violations of the Act or regulations upon the issuance of additional sewer connection permits. In R74-3 the Board adopted Water Rule 702(e) which grants a limited exemption from the Sewer Discharge Criteria for Mercury for certain commercial laundries or cleaning services where the soaps and other materials added do not contribute to the mercury levels in the effluent. In R75-3 the Board found the record inadequate to support the proposed stricter regulation of photochemically reactive materials. The Board found it necessary to extend the exemption of Air Regulation 205(f)(2)(D) for those persons who reformulate previously high organic content solvent coatings to decrease the organic content.

The Board dismissed R75-13, Explosive Incinerator Emission Standards, because the petition lacked the 200-signature required for mandatory acceptance.

The dates of regulatory decisions and a list of regulations proposed since the last Annual report appear in the rear of this report in Appendix D.

JUDICIAL REVIEW

Two decisions rendered by the Illinois Supreme Court in the last year warrant special attention. In Processing and Books, Inc. v. PCB, 64 Ill. 2d 68, 351 N.E. 2d 865 (1976) the Supreme Court reversed the Second District Appellate Court's holding that a Complainant in an enforcement action before the Board has the burden of introducing evidence upon each of the criteria mentioned in Section 33(c) of the Act. The Court found such a burden to contradict Section 31(c) of the Act which places the burden of showing hardship mitigation upon the Respondent. The Supreme Court noted that the same erroneous conclusion had been made in a subsequent Second District case. Aurora Metal Co. v. PCB, 30 Ill. App. 3d 956, 333 N.E. 2d 461 (1975), and a previous Third District Appellate Court case. Lonza, Inc. v. PCB, 21 Ill. App. 3d 468, 315 N.E. 2d 652 (1974). In holding that a Complainant has no burden of introducing 33(c) evidence, Processing and Books necessarily means that the Board must consider 33(c) factors only to the extent which evidence on them appears in the record.

In Commonwealth Edison Company v. PCB, 62 Ill. 2d 494, 343 N.E. 2d 459 (1976) the Court upheld the First District Appellate Court's reversal and remand of Rules 203(g)(1), 204(a)(1), and 204(c)(1)(A) of the Board's Air Pollution Control Regulations for further Board consideration of the issues of technical feasibility and economic reasonableness. However, the Supreme Court reversed the First District's invalidation of Air Rule 303.

Four Appellate Court decisions have also dealt with judicial review of Board Regulations. In Shell Oil Company v. PCB, 37 Ill. App. 3d 264, 346 N.E. 2d 212 (1976) and LaClede Steel Company v. PCB, 37 Ill. App. 3d 263, 346 N.E. 2d 225 (1976) the Fifth District Appellate Court affirmed the Board's adoption of R72-2, Noise Regulations. Citing an article written by former Board Chairman David Currie, Rulemaking Under the Illinois Pollution Law, 42 University of Chicago L.R. 457 (1976), the Court criticized the standard of review used in the First District Appellate Court's decision in Commonwealth Edison (25 Ill. App. 3d 271, 323 N.E. 2d 84) (1974) and disapproved another Fifth District decision which had followed the standard announced by the First District in Commonwealth Edison (see Peabody Coal Company v. PCB, 36 Ill. App. 3d 5, 344 N.E. 2d 279 (1976)). Citing Illinois Coal Operators Assn. v. PCB,

59 Ill. 2d 305, 319 N.E. 2d 782 (1974) the Fifth District rejected a "manifest weight of the evidence" standard for the review of the Board's rulemaking function and held that a rule adopted pursuant to statutory authority will not be set aside unless the action of the Board in adopting the rule is proven to have been arbitrary and capricious. The Court held the considerations delineated in Section 27 of the Act to be flexible ones which do not place a burden of proof upon the Board. However, in Village of Lombard v. PCB, 37 Ill. App. 3d 440, 346 N.E. 2d 196 (1976) the Second District Appellate Court did not find it necessary to reach the issue of standards for review. The Court held that the Act simply did not give the Board the authority to order the regionalization of wastewater treatment in DuPage County. The Board's adoption of R70-17 was thereby reversed. This decision has been appealed to the Supreme Court.

In the consolidated appeal of three related Second District Appellate Court cases the Supreme Court held that the sewer ban imposed by the Board upon the North Shore Sanitary District did not revoke pre-existing permits. The Court thus held that such parties were not in violation of that Board Order. North Shore Sanitary District v. PCB; Kaeding v. PCB; Bederman v. PCB, 62 Ill. 2d 385, 342 N.E. 2d 376 (1976). Of significance is the fact that in affirming the judgments of the Second District the Supreme Court did not rely upon or approve the grounds for the Kaeding and Bederman decisions which were used by that lower court. The Second District had held that exercise of the State's police powers were estopped in these cases because of the pre-existing permits, even though the parties could not have acted in reliance of these permits due to the fact that they were unaware that any permits existed.

In Monsanto Co. v. PCB, 39 Ill. App. 3d 333, 350 N.E. 2d 289 (1976) the Fifth District Appellate Court reversed and remanded a variance case where the Board determined that the Act would not permit a variance in excess of one year. Since that time, the General Assembly amended Section 36 (P.A. 79-1064) to allow five-year variances. The Court, however, ruled that Board variances may be granted pursuant to either Section 35 or 36 of the Act, and that Section 35 allows permanent variances. Section 36 variances, the Court ruled, apply where the sole hardship is the need for delay to correct the violation, and are limited to five years. This decision has been appealed to the Supreme Court. In another Fifth District case that Court upheld a Board determination that a cooling lake formed by damming a stream is a "water of the State" and thus subject to the Board's jurisdiction. Central Illinois Public Service Company v. PCB, 36 Ill. App. 3d 397, 344 N.E. 2d 229 (1976). In May v. PCB, 35 Ill. App. 3d 930, 342 N.E. 2d 784

(1976) the Second District Appellate Court upheld the Board's jurisdiction over the application of sludge from sewage treatment plants onto farmland for the purposes of crop fertilization and soil enrichment. The Court held the sludge to be "wastewater" under Water Rule 104 and the application mechanism to be a "Treatment Works", thus requiring a permit under Section 12(b) of the Act.

The Second District Appellate Court has provided further guidance to the Board on the issue of assessing penalties. In Aluminum Coil Anodizing Corp. v. PCB, 40 Ill. App. 3d 785, 351 N.E. 2d 612 (1976) the Court found that the penalty was proper because it would aid in the enforcement of the Act by working to secure voluntary compliance in other cases.

The Supreme Court has also rendered two decisions, which, although not based upon direct review of Board Orders, will have a great impact upon this State's environmental agencies. In Carlson v. Village of Worth 62 Ill. 2d 406, 343, N.E. 2d 493 (1975) the Court held that the Environmental Protection Act pre-empts local zoning ordinances as they relate to the siting and location of landfills. In its Supplemental Opinion on Denial of Rehearing the Court further held that the Agency has the duty and authority to take local land use factors into consideration when issuing development permits for landfills. The Court has thus held the location of landfills to require uniform state-wide regulation which considers local land use factors but is not bound by local zoning ordinances. The Court has also held the environmental regulation of regional sewage treatment plants to be beyond the authority of home rule municipalities, Metropolitan Sanitary District of Greater Chicago v. City of Des Plaines, 63 Ill.2d 256, 347 N.E. 2d 716 (1976).

A chronological list of all Illinois Supreme Court decisions in which Board orders were reviewed appears as Appendix G at the rear of this report.

CASE ACTIVITY

Total cases filed before the Board in FY76 dropped to 436 from 505 the previous year. This is the lowest level of cases for any full year of Board operation. See Appendix A.

The enforcement cases filed increased from 173 in FY75 to 195. Permit appeals almost doubled from 15 to 29. Variances dropped from 317 to 203 and the decrease was almost entirely in air variances which decreased from 185 to 81. The reasons for the abrupt decrease in air variance volume is not clear but may be due in part to (a) compliance being achieved (b) the Illinois Supreme Court decision remanding the sulfur dioxide and particulate regulations and (c) the Board's own decision following Train v. NRDC that air variances could not be granted after July 31, 1975. This latter decision by the Board is under re-examination.

An analysis of the origin of citizen suits has been done for the first time. Citizen suits are defined by Board usage as those enforcement actions filed by any person other than the Illinois Environmental Protection Agency. In FY76 a total of 30 enforcement cases were filed by citizens of which 15 were filed by the Attorney General. In FY75, of 46 citizen cases, 30 were filed by the Attorney General and 16 by others.

In six years of Board activity, a total of 168 citizen cases have been filed in which 55 were by the Attorney General and 113 by others. See Appendix B. Thus, of 913 enforcement cases filed in this entire period, the 168 citizen cases accounted for 18.4%. The rash of citizen cases predicted by some when the Environmental Protection Act was adopted has not developed.

Penalties levied by the Board in FY76 totalled \$313,350 compared to \$246,824 in FY75. A total of \$1,680,880 in penalties has been levied by the Board in the past 6 years. Penalties may not be punitive but can only "aid in the enforcement of the Act" according to court decisions. A list of all penalties levied by the Board appears in Appendix F.

ADMINISTRATIVE AND FINANCIAL

The initial appropriation for FY76 was \$706,200. In June 1976 this was reduced to \$675,100 because of the State's fiscal crisis. Actual expenditures were below the final appropriation at \$627,400 (subject to final audit).

The current appropriation (FY77) is \$674,100. Since the Board operates on a "demand" basis and has no control over the number of cases or regulations filed before it the appropriations for court reporting costs and for hearing officers fees are crucial. Should these amounts not be sufficient then cases would have to be back-logged and proceedings delayed.

The Board constantly reviews its operations to determine where economies can be made and has been meeting in recent months on a biweekly basis to save both travel expenses and time. The free mailing lists for the Environmental Register are reviewed annually to make certain that its 4,300 recipients have a continuing desire to receive the Register.

FUTURE ACTIVITIES

A primary immediate objective of the Board is to render prompt decisions in those regulatory proceedings which have been delayed by the economic impact study requirements of Senate Bill 805. As soon as economic impact studies are released by the Institute for Environmental Quality the Board will promptly schedule hearings and render expeditious decisions consistent with adequate time for deliberation.

The Illinois Environmental Protection Act was a pioneer piece of legislation and established unique rights for the public. Among these are:

- Open files
- Open meetings and hearings
- Citizen suit powers (enforcement actions)
- Citizen regulatory initiative.

It is the policy of the Board that every effort must be made to ensure that the public access to the environmental protection process is not hindered. It is a further policy that the Board has an obligation to continuously inform the public on the exercise of their rights and powers under the Act. For this reason, the Board Members do accept speaking engagements and give press interviews except that pending matters are not discussed, except for information on status or on minor procedural points.

New information is constantly being generated on the effects of environmental pollution, both from the biological and economic standpoints. When it seems to be indicated that a regulation ought to be enacted or modified, various interested groups as well as the three agencies described in the Introduction can and should bring the matter before the Board. The regulations of Illinois are not "writ in stone" and should be regularly reviewed.
