INTRODUCTION

The Pollution Control Board's activities for the fiscal year from July 1, 1977 to June 30, 1978 are detailed in this annual report. For comparative purposes, data are presented for certain categories beginning with the Board's start-up on July 1, 1970.

FUNCTIONS OF ENVIRONMENTAL AGENCIES

The Board has two main functions under the Environmental Protection Act. It acts in a quasi-judicial mode when it decides enforcement, variance, and permit appeal cases. It acts in a quasi-legislative mode when it adopts rules and regulations in environmental fields.

Members of the Board are full time and may not be employed elsewhere except that they may lecture, write or teach in a manner similar to that permitted for judges. The five Board Members have a total staff of 19 persons at three locations; Chicago (headquarters), Springfield and Carbondale.

The Illinois Environmental Protection Agency is headquartered in Springfield and has approximately 600 employees. It does environmental surveillance, issues permits, processes grant applications and initiates most of the enforcement cases brought before the Board. By statute it is an automatic party in every variance request and prepares a recommendation to the Board in such proceedings.

The Institute for Environmental Quality was the third of the sister agencies created by the 1970 statute. The General Assembly in mid-1978 merged five other State governmental agencies with it to create the new Institute of Natural Resources. Staff of the old Institute numbered 15 while the successor agency will have approximately 700.

The Institute's role in environmental management is to provide scientific, technical and economic answers to Illinois problems. It engages qualified consultants to do state-of-the-art reports or applied research. In recent years, since October 1975, the Institute has been made responsible for preparing economic impact studies which are required for all new regulations.

The Institute by law, holds an annual conference at which Statewide environmental progress is assessed. It also has a role in assisting schools on environmental education matters.

#### BOARD MEMBERSHIP

On June 1, 1978 the Illinois Senate confirmed Governor James R. Thompson's nomination of Mr. James L. Young and Dr. Donald P. Satchell to the Board for second terms ending June 30, 1981. Mr. Young, of Springfield, is an attorney and engineer and has served on the Board since October 1975. Dr. Satchell, of Carbondale, is an agronomist and soils expert and has served on the Board since December 1975.

#### REGULATORY ACTIONS

The Board took final action on fifteen regulations in Fiscal Year 1978. On July 7, 1977 it revalidated certain rules in R71-23 which concerned particulate and sulfur dioxide emissions. An old pending proceeding, R73-9, which would have regulated indirect sources of pollution (facilities such as shopping centers which generate traffic) was dismissed on August 4, 1977 because of the lack of Federal involvement in this area.

On October 13, 1977 a regulation setting thermal standards for Lake Sangchris (R76-11) was adopted. A pending proceeding, R76-4, dealing with water discharge permits, was dismissed on November 10, 1977 as being moot because of the delegation of NPDES permit authority to Illinois from the Federal government.

The distinction between polar and non-polar fats, oils and greases in effluents was recognized by the Board in the adoption of R74-1 on November 23, 1978. On the same date, R76-5 was enacted, setting a process weight emission standard for air furnaces located in Hoopeston.

A revision to carbon monoxide emission rules, R75-9, was enacted on December 8, 1977 to reflect attainable levels from certain chemical plants.

An air episode regulation, R75-4, was finalized on March 30, 1978 when the economic impact study proceedings were analyzed. The regulation had been enacted two years earlier, on April 9, 1976, under the public health emergency powers granted to the Board.

Changes to public notice rules dealing with NPDES permits were adopted in R73-11 on March 30, 1978. Procedural rule changes to conform to new legislation were enacted on the same date in R77-16. A regulation to permit the burning of coal refuse at a power plant in Williamson County was approved also on the same date in R75-10.

The severe ice storm in Illinois on March 23-24, 1978 caused widespread damage to trees. The Board on April 13, 1978 adopted R78-2 which permitted open burning of tree limbs in the 24 counties in Illinois declared a disaster area by Governor James R. Thompson. The enactment was for a 150-day period under Board emergency powers.

On May 11, 1978 the Board adopted R75-11 setting new requirements for motor racing noise. A specific water quality standard for boron was adopted on May 25, 1978 for Wood River Creek in R76-18. Certain exemptions to the ammonia nitrogen requirements effective until July 1, 1982 were adopted in R77-6 on June 22, 1978.

#### CASE ACTIONS

The total number of cases filed before the Board in FY78 increased to 353 from the low of 317 filed in FY77. Enforcement cases increased to 141 from 89 for the previous year. Variances decreased to 155 from 187. Appendix A gives the distribution by types of cases for the entire eight years of the Board's existence. Appendix B gives the distribution by type of "citizen" cases (those filed by private citizens or by the Attorney General in the name of the People of Illinois). In FY78 there were 22 of these "citizen" cases compared to 40 in FY77.

The Board levied \$108,975 in penalties in 59 cases in FY78 compared to \$219,382 in 84 cases in the previous year. A total of \$1,962,955.76 (including interest assessed by court order) has been levied in 705 penalty cases to date. Appendix F lists all penalties levied by the Board and the status of collection.

#### ADMINISTRATIVE AND FINANCIAL

Board expenditures in FY78 were \$624,700 compared to the appropriation of \$703,300. Expenditures are subject to final audit for verification. The FY79 appropriation for the Board is \$693,600.

The Board has tried to economize wherever possible. Court reporting services have been engaged after obtaining bids and multiple transcripts are not purchased. Labor saving word processing equipment is being used. Excess lighting levels have been reduced to save money and energy. Appendix E gives the details of the Board expenditures since its starting.

## THE COMING YEAR

Last year's annual report mentioned the enactment of the Clean Air Act Amendments as of August 7, 1977. Under this Federal law, States such as Illinois where some areas do not yet meet national air quality standards must enact new air regulations by January 1, 1979. Hearings are underway at this writing but it is doubtful if the economic impact studies required by Illinois law will be completed in time to meet that date for all of the needed regulatory revisions. Sanctions in the form of forfeiture of Federal funds for program purposes and for sewage plant and highway construction purposes can be invoked. Other states are all having similar time difficulties and it is not likely that funds will be forfeited if a good faith effort toward revision is made.

In the coming year, the Board will make an effort to reduce the number of pending regulations before it. At the end of FY78 approximately 30 regulations were pending before the Board. Most of these were awaiting economic impact studies before final action by the Board is possible.

The trend seems clear that national emission or effluent standards in air and water are becoming more prevalent. Illinois industry and municipalities are subject to the Federal regulations regardless of State action or inaction. To the extent that Illinois can conform its rules to the Federal rules, the environmental framework can be simplified. However, national regulations may not completely protect the Illinois environment and must be carefully examined.

The Illinois Environmental Protection Act, under which the Board was created, remains a unique and innovative statute. Citizens may bring environmental suits before the Board if their complaints are not duplicitous or frivolous. And citizens may initiate regulatory proceedings if 200 signatures are obtained in their petition. These are checks and balances built into the legal system to guard against government inaction.

The separation of functions between the various environmental agencies has been detailed earlier. It is working well. But citizens new to Illinois or new to environmental matters must have it explained to them in order that they can intelligently participate in the system. For this reason, Board Members are happy to be invited as guest speakers to audiences interested in the functions or activities of the Board.

Environmental protection should change as new scientific or economic facts are developed. The task of the Board in the coming year and future years is to keep up with new facts so that incorrect or unduly expensive rules are not retained and so that the public health is adequately protected.

## JUDICIAL REVIEW

During the past year, there have been 22 cases reviewed by the Courts. Among these cases, there have been cases which affect: the Board's choice of counsel to represent it in judicial proceedings; the Board's definition of a frivolous claim; and, the power of local governments to regulate pollution through zoning laws.

In EPA V. PCB, 69 Ill.2d 394, 372 N.E.2d 50(1977), the Supreme Court declared that the Attorney General may represent both sides in cases with feuding state agencies, so long as he is not involved as a private individual or as a party. This decision affirmed two lower court refusals to appoint private counsel for the Board in appellate cases brought by the Attorney General representing the Agency.

In Winnetkans Interested in Protecting the Environment (WIPE) v. PCB and EPA, 55 Ill.App.3d 475, 370 N.E.2d 1176 (1977), the First District Appellate Court upheld the Board's definition of "a frivolous claim" as one that is either legally or factually deficient and fails to state a cause of action upon which relief can be granted. The Board had dismissed WIPE's claim for being frivolous and duplicitous in part. While upholding the Board's decision that the claim was frivolous, the Appellate Court held that the claim was not duplicitous, since it stated facts and issues which were not precisely the same as those in a prior suit before the Board.

In another case, City of Des Plaines, et al v. Metropolitan Sanitary District, EPA and PCB, (First District, No. 76-1186, 5/15/78), the Court again upheld the Board's action in dismissing a citizens' complaint. The complaint challenged the Agency's issuance of a permit for the operation of the O'Hare Reclamation Plant. The Court reaffirmed the Board's definition of a "frivolous" claim and held that the complaint had to state facts, not just conclusions of law. Since there was no allegation of an actual threat of pollution, the mere existence of a "hazard" was insufficient. The Court also affirmed the Board's refusal to allow the complaint to be amended as a permissible attempt to put an end to protracted litigation.

In Village of Union v. Southern California Chemical Company, 59 Ill.App.3d 373, 375 N.E.2d 489 (1978), the Second District Appellate Court held that a municipal government may not enact a zoning ordinance to regulate an environmental matter of state-wide concern when such a matter is governed state-wide by the Illinois Environmental Protection Act. Southern California

Chemical was convicted of violating the Village's zoning ordinances regulating air pollution. Citing several Supreme Court cases, including City of Des Plaines v. Chicago and Northwestern Ry. Co., 65 Ill.2d 1, 357 N.E.2d 433 (1976) and Carlson v. Village of Worth, 62 Ill.2d 406, 343 N.E.2d 493 (1976), the Court said that the zoning ordinance attempted to regulate a matter already preempted by the Act. The Court noted that the purpose of the Act was to establish a unified, state-wide program of protection and enforcement. For these reasons, the court reversed Southern California Chemical's conviction.

However, in Harry Carlson, et al v. Dr. Richard H. Briceland and the Illinois Environmental Protection Agency and County of Cook (First District, No. 76-1467, 6/7/78), the Court held that Cook County's zoning restrictions were applicable to Carlson's sanitary landfill operations. Recent decisions have held that the Environmental Protection Act preempts local regulation of pollution. In departing from this trend, the Court noted that while a unified, state-wide approach to pollution is favored by the courts, the subject of landfills has been historically a matter for local regulation. The Court ruled that a home rule entity such as the county was better able to provide minimum due process protection for the rights of persons or municipalities adversely affected by the location of garbage disposal sites. The dissent noted that prior decisions have already determined that sanitary landfills are matters of regional and statewide concern. See, O'Connor v. City of Rockford, 52 Ill.2d 360, 288 N.E.2d 432 (1972) and Carlson v. Village of Worth, 62 Ill.2d 406, 343 N.E.2d 493 (1976).

There was also a case dealing with an injunction against the Board's proceedings.

In Landfill, Inc. v. PCB, 52 Ill.App.3d 154, 367 N.E.2d 347 (1977), the First District Appellate Court upheld a preliminary injunction against the Board's proceedings on this case. The injunction was sought by Landfill to stop the Board's proceedings involving the construction of a landfill in Palos Park. Without deciding whether all administrative remedies had been exhausted, the Court stated that Landfill's complaint stated good cause for a preliminary injunction, and noted that no responsive pleading had been filed.

The noise regulations were among those Board regulations reviewed by the Courts this year.

The First District Appellate Court affirmed the Board's regulation on noise pollution from stationary sources in Illinois State Chamber of Commerce v. PCB and Association for

Motor Sports of Illinois v. PCB, 49 Ill.App.3d 954, 364 N.E.2d 631 (1977). Following the Supreme Court's decision in Illinois Coal Operators Association v. PCB, 59 Ill.2d 305, 319 N.E.2d 782 (1974) and the Fifth District Appellate Court decision in Shell Oil Co. v. PCB, 37 Ill.App.3d 264, 346 N.E.2d 212 (1976), the Court held that the prohibition in Rule 102 was not beyond the Board's authority. The rule prohibits noise pollution which unreasonably interferes with the enjoyment of life or with any lawful business, or which violates the Board's standards.

The Board's NPDES regulations were also upheld.

In U.S. Steel Corporation v. PCB, 52 Ill.App.3d 1, 367 N.E.2d 327 (1977), the Second District Appellate Court upheld the Board's NPDES regulations. Rule 410(b) was held to be within the Board's authority. This rule provides that compliance with an NPDES permit does not exempt a discharger from compliance with effluent and water quality standards not stated in its permit. Rules 909(h) and 910(a)(6) were also upheld. Rule 909(h) makes NPDES permits fully effective when issued, and Rule 910(a)(6) allows the Agency to use its best judgment in setting limitations for which no federal standard has been promulgated. The Court also felt that Rule 910(e), which provides for automatic permit modifications to include toxic pollutant limitations, was not a denial of due process.

However, other Board regulations were successfully challenged.

In People v. Leonard and Agnes Keeven (Madison County Circuit Court, No. 77-CH-138, 9/8/77), Associate Judge Day ruled that the exception created by Rule 951(b)(2) of Chapter 3 was unconstitutional and unenforcible. The Attorney General was unable to get an injunction to prevent a sewer hookup of an apartment building in Highland, Illinois, which is presently on a restricted status. The rule would have allowed the injunction, since under the rule the connection would be allowed only if it were intended for a single building with no more than 1,500 gallons of sewage per day.

In yet another case, County of Cook v. John Sexton Contractors Co., et al. and John Sexton Contractors Co., et al. v. County of Cook, PCB and Village of Richton Park (Cook County Circuit Court, Chancery Division, No. 77-CH-1445, 10/27/77), Judge Berg ruled that the Board's Procedural Rule 503(a) and Solid Waste Rule 205 (j) were invalid. These rules allow third parties to appeal the Agency's action of granting permits.

The Court stated that the proper remedy for review was a suit for declaratory judgment, and that the Agency could not be sued before the Board for violation of the Environmental Protection Act.

However, in Landfill, Inc. v. Illinois Pollution Control Board, et.al. (Cook County Circuit Court, Law Division, No. 76-L-20178, 1/18/78), Judge Curry's order overruled Judge Berg's decision and held that Procedural Rule 503(a) and Solid Waste Rule 205(j) were authorized by the Act.

Again, this year the greatest number of cases involved enforcement matters. Three cases dealt with water pollution.

In EPA v. CILCO, 54 Ill.App.3d 155, 369 N.E.2d 389 (1977), the Third District Appellate Court held that CILCO's cooling reservoir was not an "artificial cooling lake" as defined by Rule 104 of Chapter 3, but was a treatment works. The Board found CILCO in violation of a Board regulation which requires a permit to construct an "artificial cooling lake". The Court held that in view of the record, the reservoir was more properly classified as a treatment works. As a treatment works, the cooling reservoir was exempt from thermal water quality standards. Quoting the Board's Opinion in adopting the cooling lake regulation, the Court said:

Where artificial diking is erected, and water to fill the resulting enclosure is largely...obtained by withdrawal from a nearby natural body of water such as a lake or river, the enclosure constitutes a treatment works.

In Harry Von Abel, et al. v. PCB and EPA, (Fifth District, No. 76-354, 4/13/78), the Court upheld the Board's penalty of \$2,000 for operating a mine refuse reclamation facility without a permit, since all operations had not ceased. The Court found sufficient evidence to support the Board's findings that the facility operated without a permit, and that the appellants caused water pollution.

But, in EPA v. Harold Craig and Robert Craig (Fourth District, No. 14417, 4/17/78), the Court overruled the Board's penalty of \$1,345.40 for causing a fish kill, because the order was not supported by expert evidence linking the fish kill to the Craigs' operations. However, the Court found sufficient evidence to uphold the Board's cease and desist order and the penalty of \$500 for water pollution.

There were also two cases dealing with air pollution.

In Wells Manufacturing Co. v. Citizens For a Better Environment, 48 Ill.App.3d 337, 363 N.E.2d 26 (1977), the First District Appellate Court reversed the Board's findings that Wells caused air pollution through odor emissions, and held that Wells was entitled to an operating permit. The court stated that the Board failed to consider Wells' good faith attempts at compliance or that all the complaining witnesses had moved into the area after Wells started its operation.

In City of Chicago v. PCB and EPA, 57 Ill. App.3d 517, 373 N.E.2d 512 (1978), the First District Appellate Court reversed a Board order which levied a \$10,000 penalty upon the City of Chicago for emissions from its Southwest Incinerator. The Court felt that the City had done everything reasonably possible to reduce emissions. Since the Agency had not requested a penalty, the Court felt that the Board was overly vindictive in assessing one.

Finally, there was a case dealing with solid waste disposal.

In R. E. Joos Excavating Co. v. EPA and PCB, 58 Ill. App.3d 309, 374 N.E.2d 486 (1978), the Third District Appellate Court upheld the Board's levying of a \$1,500 penalty for operating without a permit. The Court agreed with the Board's position that the exception of §21(e) of the Environmental Protection Act should only apply to refuse generated on the site where it is to be disposed of.

There were five cases dealing with the Board's power to grant or deny variances.

In PPG Industries, Inc. v. EPA, 50 Ill.App.3d 888, 365 N.E.2d 1325 (1977), the Fourth District Appellate Court affirmed the Board's denial of PPG's requested variance. The Court agreed that it was not unreasonable for the Board to hold PPG responsible for suspended solids entering its pond from nonplant sources when the sole reason for the existence of the pond was to meet PPG's manufacturing needs.

Olin Corp. v. EPA and PCB, 54 Ill.App.3d 480, 370 N.E.2d 3 (1977), reaffirmed the notion that there are no permanent variances. The Fifth District Appellate Court held that the only way to reclassify a stream under Rule 302(k) of Chapter 3 was through a regulatory proceeding before the Board, though on occasion the Board had evaluated stream reclassification in some non-regulatory proceedings.

In Flintkote Co. v. PCB and EPA, 53 Ill.App.3d 665, 368 N.E.2d 984 (1977), the Fifth District also revised a portion of a Board Order requiring Flintkote to sign a certificate of acceptance of the terms of a variance. The Court felt that this would have deprived Flintkote of its right to appeal. However, the Court affirmed the part of the order requiring compliance with the conditions of the variance, noting that it appeared that Flintkote could comply some of the time. Citing Monsanto Co. v. PCB, 67 Ill.2d 276, 367 N.E.2d 684 (1977), the Court said that conditions of a variance cannot be overturned unless they are found to be arbitrary, unreasonable or capricious.

In Harris Hub Co., Inc. v. PCB, 50 Ill.App.3d 608, 365 N.E.2d 1071 (1977), the First District Appellate Court ruled that no penalty should be assessed for operating without a permit, when the penalty would not aid in the enforcement of the Act. In overruling the Board's imposition of a penalty, the Court noted that Harris-Hub was not a polluter and that its good faith efforts to comply with Air Pollution regulation were a mitigating factor. The Court said that a violation of the Act does not necessarily warrant the sanction of a penalty. The imposition of a penalty must be shown to aid in the enforcement of the Act.

The Second District Appellate Court affirmed the Board's decision in Armour-Dial v. EPA, People of Illinois and PCB, Ill.App.3d \_\_\_\_\_, 376 N.E.2d 411 (1978). In reviewing the Board's denial of a variance related to odors and hydrocarbon emissions, the Court stated that the proper standard of review was the "manifest weight" rule. The Court said that Armour-Dial had failed to establish sufficient hardship that was not self-imposed and also had failed to justify the requested period for compliance. The Court also upheld the Board's conclusion that Armour-Dial might be causing violations of ambient air quality.

The Courts reviewed two cases dealing with permits.

In Ashland Chemical Co. v. PCB and EPA, 57 Ill.App.3d 1052, 373 N.E.2d 826 (1978), the Third District Appellate Court reversed the Board's denial of an operating permit. In an earlier variance proceeding, the Board found that Ashland's operations did not violate ambient air standards. Ashland asserted the doctrine of res judicata and claimed that the Board's finding in the variance proceeding was conclusive on the question of compliance with ambient air quality standards. The Court agreed and held that the earlier finding

constituted prima facie evidence of compliance and that, in the absence of contrary data, the Board had no basis for its denial.

In Commonwealth Edison Company v. People of the State of Illinois, 49 Ill.App.3d 954, 364 N.E.2d 631 (1977), the Third District Appellate Court dismissed Commonwealth Edison's appeal as moot. While the Board ruled that Edison's disposal of fly ash into a quarry required a permit, it assessed no penalty. Since a permit had been obtained in the interim, the Court dismissed the appeal.
