JURISDICTION

This Administrative Citation is issued pursuant to authority vested in the Illinois Environmental Protection Agency by 415 ILCS 5/1 et. seq., specifically 415 ILCS 5/31.1.

FACTS

- 1. The Respondent, Christopher Will, is the present owner, occupant and in control and possession of a facility located in the County of Jackson, State of Illinois.
- 2. The facility is an open dump, operating without an Illinois Environmental Protection Agency Operating Permit, and designated with the Site Code # 077 812 5014. The facility is known to the agency as the Pomona/Christopher Will site.
- 3. The Respondent has owned, occupied, controlled and/or operated the facility at all material times hereto.
- 4. On September 11, 2014, Don Terry, Field Inspector, Jackson County Health Department, and Phillip Pierce-Savoie, Environmental Protection Specialist, Illinois Environmental Protection Agency, inspected the facility. A true and correct copy of the inspection report, along with Mr. Terry's affidavit, are attached and incorporated herein by reference as Exhibit A.

- On July 25, 2013 this Board adopted its final opinion and order in Docket No. AC
 13-31 in a case involving this Respondent and this site.
- 6. In Docket No. AC 13-31 the Respondent was found to have violated Sections 21(p)(1), (p)(2), (p)(3) and (p)(7).

VIOLATIONS

On the basis of Field Inspector Don Terry's direct observation he has determined that the Respondent has caused or allowed open dumping at the above described facility in a manner that resulted in the following violations:

That on September 11, 2014, an inspection of the facility disclosed the following:

- 1. The Respondent has caused or allowed litter at the facility in violation of 415 ILCS 5/21(p)(1).
- 2. The Respondent has caused or allowed open burning at the facility in violation of 415 ILCS 5/21(p)(3).
- 3. The Respondent has caused or allowed the proliferation of disease vectors at the facility in violation of 415 ILCS 5/21(p)(5).
- 4. The Respondent has caused or allowed the deposition of general or clean construction or demolition debris at the facility in violation of 415 ILCS 5/21(p)(7).

CIVIL PENALTY

Pursuant to Section 42(b)(4-5) of the Act, 415 ILCS 5/42(b)(4-5), Respondent is subject to a civil penalty of One Thousand Five Hundred Dollars (\$1,500.00) for the Section 5/21(p)(5) violation; and Three Thousand Dollars (\$3,000.00) each for the other three violations identified above (being second, subsequent violations), for a total of <u>TEN THOUSAND FIVE HUNDERD</u> <u>DOLLARS (\$10,500.00)</u>. If the Respondent elects not to petition the Illinois Pollution Control

Board, the statutory civil penalty specified above shall be due and payable no later than December 15, 2014, unless otherwise provided by order of the Illinois Pollution Control Board.

If the Respondent elects to contest this Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1, and if the Illinois Pollution Control Board issues a finding of violation as alleged herein, after an adjudicatory hearing, Respondent shall be assessed the associated hearing costs incurred by the Illinois Environmental Protection Agency and the Illinois Pollution Control Board. The hearing costs shall be assessed in addition to the statutory civil penalties for each violation.

Pursuant to Section 31.1(d)(1) of the Act, 415 ILCS 5/31.1(d)(1), if the Respondent fails to petition or elect not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and findings of violation as alleged herein, and shall impose the statutory civil penalties specified above.

When payment is made, checks shall be made payable in equal amounts (50% of total penalty each) to:

- County of Jackson, c/o Jackson County Treasurer, Jackson County Courthouse,
 Murphsyboro, Illinois 62966; and
- (2) Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276.

Respondent shall complete and return the enclosed Remittance Forms with payments to ensure proper documentation of payment. If any civil penalty and/or

hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs shall be assessed against the Respondent from the date payment is due up to and including the date that payment is received. The Complainant may either initiate proceedings against the Respondent in Circuit Court or other debt collection actions to collect said penalty and/or hearing costs, plus any interest accrued.

PROCEDURE FOR CONTESTING ADMINISTRATIVE CITATION

You have the right to contest this Citation, pursuant to 415 ILCS 5/31.1. If you elect to contest this Citation, you must file a Petition For Review with the Clerk of the Illinois Pollution Control Board. YOUR PETITION FOR REVIEW MUST BE FILED WITHIN 35 DAYS OF THE DATE OF SERVICE OF THE PRESENT CITATION ON YOU. YOUR PETITION MUST STATE THE REASON(S) YOU BELIEVE THE PRESENT MATTER SHOULD NOT BE ISSUED. IF YOU FAIL TO FILE YOUR PETITION AND STATE THE REASONS THE PRESENT MATER SHOULD NOT BE ISSUED, A DEFAULT ORDER AGAINST YOU WILL BE ENTERED BY THE POLLUTION CONTROL BOARD.

GENERAL REMARKS

Background: On December 18, 2012, an inspection was made of this site which lead to Jackson County filing an Administrative Citation against the site owner, Christopher Will. During the inspection, the open dumping, open burning and burying of waste was observed. The Illinois Pollution Control Board (IPCB) accepted the filing as AC 13-31. On July 25, 2013, the IPCB ruled that Mr. Will had violated Sections 21(p)(1), (p)(2), (p)(3) and (p)(7) of the Illinois Environmental Protection Act (Act) and ordered him to pay civil penalties of \$6000. As of the time of this inspection, Mr. Will has not paid the fine nor provided proof that he fully cleaned up his site.

During the stated date and time, Philip Pierce-Savoie of the Illinois Environmental Protection Agency (IEPA) and I conducted an inspection of the site listed above. This inspection was made as a follow up to a complaint received by the US EPA. The US EPA forwarded the complaint to the Illinois EPA who then forwarded it to the Jackson County Health Department. The complainant stated that Mr. Will, who owns a construction company, was bringing waste from his business activities and disposing of the waste at his site by burning and burying. The complainant alleged that some of the wastes being brought to the site for disposal included waste tires, shingles, antifreeze and used oil. Weather conditions at the time of the inspection were: Cloudy with a temperature of approximately 62°F.

Upon arrival at the site, Mr. Pierce-Savoie and I were approached by a man who had arrived at the site just prior to us. After we introduced ourselves and showed him our credentials, the individual identified himself as Jimmie Lee and said that Mr. Will, the site owner was not at the site. Mr. Lee said he was not comfortable with us being at the site. Mr. Pierce-Savoie asked Mr. Lee if he was a tenant, with Mr. Lee responding that he was staying at the site. Mr. Pierce-Savoie explained that the Act allowed us to be on the site to conduct an inspection as long as the owner did not object. Mr. Pierce-Savoie and I waited several minutes for Mr. Lee to try to contact Mr. Will by phone, with no success. At this time Mr. Pierce-Savoie told Mr. Lee that we were going to proceed with the inspection of the site.

I walked south along the driveway and observed piles of general construction / demolition debris sitting on the ground (**Photo #1, Site Sketch**). The waste in this area included, but was not limited to: plywood, roofing tin and dimensional lumber. At the time of the inspection, the items listed as waste were not in use and were not stored in such a way as to protect any future use.

As I continued walking south, I observed several waste vehicles (Photos #2, #3 & #5, Site Sketch). These waste vehicles were not in use, were not useable in their current condition, and were not stored in such a way as to protect any future use. In one location I observed an area partitioned into three areas (Photo #4, Site Sketch). The areas were holding scrap metal. The areas were also overgrown with vegetation, which would indicate that the scrap metal had been sitting at this location for at least this growing season without being disturbed.

I walked east to a location where I had observed the open burning and burying of general construction / demolition debris during my December 18, 2012 inspection. Today I observed two areas of roofing shingles that were lying on the ground, charred and partially melted (Photos #6 & #7, Site Sketch). In both areas I observed charred vegetation near the charred shingles and new vegetation beginning to grow up around the area. This would indicate that roofing shingles were brought to this site, placed on the ground and disposed by open burning.

I walked east, down an embankment toward an intermittent stream. During my previous inspection, I observed buried waste and open dumped waste coming out of the fill face and lying in the intermittent stream. Today I observed downed trees and open dumped waste (Photos #8 & #9, Site Sketch). The waste included but was not limited to: a waste tire, dimensional lumber, plastic items and plastic pipe. I also observed waste protruding from the "fill face," (Site Sketch – X; See Photos #019 and #020 on Attachment: Page 1).

I walked west, up the embankment, and then south. I observed a pile of decking, composed of dimensional lumber (Photo #10, Site Sketch). At the time of the inspection, this material was not in use and was not stored in such a way as to protect any future use. South of the structure labeled Shed C on the Site Sketch, I observed a waste pile in an area of discolored soil, devoid of vegetation (Photo #11, Site Sketch). The waste in this pile consisted of but was not limited to: ash, dimensional lumber, scrap metal and vegetation. Some of the waste in this pile was charred and the vegetation in and around the pile was either gone or dead.

I looked south and observed what appeared to be another waste pile near a tree line. I walked to the location and observed a waste pile (Photos #12 - #15, Site Sketch). The waste in the pile consisted of, but was not limited to: ash, vegetative matter, dimensional lumber, scrap metal, bricks, concrete, broken tile, plastic items, gypsum board, metal cans and nails. I observed that the ground, much of the waste in the pile as well as surrounding vegetation was charred, indicating that the waste was open burned at this site. I also observed that the waste, along with soil, had been pushed into a ravine with some of the waste being buried. This disposal method is similar to what I observed during my 12/18/2012 inspection.

On the way back to the vehicle, Mr. Lee said that Mr. Will was on his way to the site. Mr. Pierce-Savoie pointed out a waste/used tire near the residence holding water (Site Sketch; See Photos #033 on Attachment: Page 2). Within the tire, I observed mosquito larvae. Then, Mr. Pierce-Savoie and I waited in the vehicle for Mr. Will. Mr. Will approached the vehicle and appeared angry. He spoke loudly using profane language. Mr. Pierce-Savoie explained the purpose of our visit and the apparent violations we found. Mr. Will was told that a decision as to what would be the next step in the process would be determined by Jackson County and the IEPA.

The total volume of waste observed was approximately 100 cubic yards or more.

My inspection ended at approximately 10:30 a.m.

<u>Item #1(9)(a)</u>: Cause, threaten or allow air pollution in Illinois; <u>Item #2(9)(c)</u>: Cause or allow open burning; <u>Item #8(21)(p)(3)</u>: Cause or allow the open dumping of any waste in a manner which results in any of the following occurrences at the dump site: (3) Open Burning: During the inspection the open dumping of waste that resulted in open burning and which caused, threatened or allowed air pollution in Illinois was observed.




