HEARING OFFICER ORDER

On April 30, 2015, the parties informed the hearing officer that the Illinois Environmental Protection Agency still needs to review the draft permit, but that the parties remain optimistic that a permit will be issued. The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including December 17, 2015.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on August 20, 2015, at 10:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a motion to voluntarily dismiss is filed prior to the next status conference, the conference will be cancelled without further notice.
