<u>JURISDICTION</u>

This Administrative Citation is issued pursuant to the authority vested in the Illinois Environmental Protection Agency by Section 31.1 of the Illinois Environmental Protection Act, 415 ILCS 5/31.1 (2014).

FACTS

- 1. That John E. Laverdiere is the current owner and Laverdiere Construction, Inc.is the current owner ("collectively Respondents") of a facility located at 800 South Ward Street, Macomb, McDonough County, Illinois. The property is commonly known to the Illinois Environmental Protection Agency as Laverdiere, John E..
 - 2. That said facility is designated with Site Code No. 1090355111.
 - 3. That Respondents have owned or operated said facility at all times pertinent hereto.
- 4. That on March 30, 2015, Robert J. Wagner of the Illinois Environmental Protection Agency's ("Illinois EPA") Peoria Regional Office inspected the above-described facility. A copy of his inspection report setting forth the results of said inspection is attached hereto and made a part hereof.

5. That on <u>4-28-15</u>, Illinois EPA sent this Administrative Citation via Certified Mail No. <u>7012 0470 0001 3000 6124 - Lavandiera</u>.

VIOLATIONS

Based upon direct observations made by Robert J. Wagner during the course of his March 30, 2015 inspection of the above-named facility, the Illinois Environmental Protection Agency has determined that Respondents have violated the Illinois Environmental Protection Act (hereinafter, the "Act") as follows:

- (1) That Respondents caused or allowed the open dumping of waste in a manner resulting in litter, a violation of Section 21(p)(1) of the Act, 415 ILCS 5/21(p)(1) (2014).
- (2) That Respondents caused or allowed the open dumping of waste in a manner resulting in deposition of waste in standing or flowing waters, a violation of Section 21(p)(4) of the Act, 415 ILCS 5/21(p)(4) (2014).
- (3) That Respondents caused or allowed the open dumping of waste in a manner resulting in deposition of general construction or demolition debris: or clean construction or demolition debris, a violation of Section 21(p)(7) of the Act, 415 ILCS 5/21(p)(7) (2014).

CIVIL PENALTY

Pursuant to Section 42(b)(4-5) of the Act, 415 ILCS 5/42(b)(4-5) (2014), Respondents are subject to a civil penalty of One Thousand Five Hundred Dollars (\$1,500.00) for each of the violations identified above, for a total of <u>Four Thousand Five Hundred Dollars (\$4,500.00)</u>. If

not to petition the Illinois Pollution Control Board, the statutory civil penalty specified above shall be due and payable no later than <u>June 15, 2015</u>, unless otherwise provided by order of the Illinois Pollution Control Board.

If Respondents elect to contest this Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1 (2014), and if the Illinois Pollution Control Board issues a finding of violation as alleged herein, after an adjudicatory hearing, Respondents shall be assessed the associated hearing costs incurred by the Illinois Environmental Protection Agency and the Illinois Pollution Control Board. Those hearing costs shall be assessed in addition to the One Thousand Five Hundred Dollar (\$1,500.00) statutory civil penalty for each violation.

Pursuant to Section 31.1(d)(1) of the Act, 415 ILCS 5/31.1(d)(1) (2014), if Respondents fail to petition or elect not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and findings of violation as alleged herein, and shall impose the statutory civil penalty specified above.

When payment is made, Respondent's check shall be made payable to the Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Along with payment, Respondents shall complete and return the enclosed Remittance Form to ensure proper documentation of payment.

If any civil penalty and/or hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs shall be assessed against the Respondents from the date payment is due up to and including the date that payment is received. The Office of the Illinois Attorney General may be requested to initiate proceedings against Respondents in Circuit Court to collect said penalty and/or hearing costs, plus any interest accrued.

PROCEDURE FOR CONTESTING THIS ADMINISTRATIVE CITATION

Respondents have the right to contest this Administrative Citation pursuant to and in accordance with Section 31.1 of the Act, 415 ILCS 5/31/1 (2014). If Respondents elect to contest this Administrative Citation, then Respondents shall file a signed Petition for Review, including a Notice of Filing, Certificate of Service, and Notice of Appearance, with the Clerk of the Illinois Pollution Control Board, State of Illinois Center, 100 West Randolph, Suite 11-500, Chicago, Illinois 60601. A copy of said Petition for Review shall be filed with the Illinois Environmental Protection Agency's Division of Legal Counsel at 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Section 31.1 of the Act provides that any Petition for Review shall be filed within thirty-five (35) days of the date of service of this Administrative Citation or the Illinois Pollution Control Board shall enter a default judgment against the Respondents.

Narrative

On March 30, 2015, I (Robert J. Wagner) inspected property owned by John "Jack" E. Laverdiere. See attached property deed. The property is located at 800 South Ward Street, Macomb, Illinois. The inspection was a result of citizen complaint C-2015-013-P.

The complainant alleged construction debris is being dumped in a field near a waterway by Laverdiere Construction Inc.

I arrived at the property and observed a No Trespassing sign and a No Dumping sign at the driveway entrance. I could see chunks of concrete, and processed wood in plain view open dumped on the property.

It appeared that demolition debris is being used to fill in a low-lying area of the property. The demolition debris is being dumped and pushed towards the adjacent waterway. Photographs 1, 2, 3, 4, 5, 6, 28, 29, 30, 44, 45, 46, and 47, show the fill area. The fill area was ¾ covered with dirt. Using the ruler tool from Google Earth, I estimate the size of the fill area to be 175 feet wide by 1 foot deep by 260 feet long in size (1685 cubic yards). I used one foot as the standard depth but believe it is much deeper in some areas of the fill.

Photographs 7 and 8 show an erosion rill. The rill had bits and pieces of asphalt pavement, red brick, and processed wood protruding from it. See attached site sketch.

Photographs 9, 10, and 11 show concrete blocks, asphalt pavement, and chunks of concrete with protruding metal bars.

Photograph 12 shows yellow painted concrete parking blocks, chunks of asphalt pavement, a wood pallet, and chunks of concrete. This debris is deposited in water. Photograph 13 shows chunks of concrete with protruding metal wire.

Photographs 14, 15, and 17 show yellow painted concrete parking blocks, chunks of asphalt pavement, a wood pallet and chunks of concrete protruding from the fill area. Photograph 16 shows yellow painted concrete parking blocks, processed wood, and chunks of concrete.

Photographs 18 and 19 show yellow painted concrete parking blocks, chunks of asphalt pavement, and chunks of concrete. Photograph 20 shows chunks of asphalt pavement, processed wood, and chunks of concrete.

Photograph 21 shows yellow painted concrete curb, chunks of asphalt pavement, chunks of concrete, paper, and processed wood. Photograph 22 shows yellow painted concrete curb, chunks of asphalt pavement, chunks of concrete, processed wood, and a mangled plastic drainage pipe.

Photograph 23 shows asphalt shingles, processed wood, and vinyl siding protruding from the fill area. Photograph 24 shows concrete chunks, processed wood, and asphalt shingles. Photograph

25 shows concrete chunks. Photograph 26 shows concrete chunks with protruding metal wire. Photograph 27 shows a concrete chunk with protruding metal bar.

Photographs 31, 32, and 33 show chunks of concrete, asphalt shingles, processed wood, and vinyl siding protruding from the fill area. Photograph 34 shows yellow painted concrete parking blocks, chunks of asphalt pavement, and chunks of concrete.

Photograph 35 shows a crushed plastic Mountain Dew bottle protruding from the fill area. Photograph 36 shows signs directing where to deposit material on the property. Photograph 37 shows bits and pieces of processed wood protruding from the ground.

Photographs 38 and 39 show plastic material protruding from the ground. Photograph 40 shows bits and pieces of processed wood protruding from the ground. Photograph 41 shows piles of asphalt pavement. Photograph 42 shows a piece of processed wood. Photograph 43 shows a no trespassing sign and a no dumping sign posted at the entrance to the property.

After walking and photographing the property, I drove to Laverdiere Construction Inc. headquarters in Macomb, Illinois. Mr. Laverdiere was unavailable. I departed Laverdiere Construction Inc.

I spoke to Mr. Jack Laverdiere via telephone about the open dumping taking place at 800 South Ward Street, Macomb, Illinois. I read two complaints (C-2015-013-P & C-2015-026-P) to him that the Agency had received from an anonymous source regarding Laverdiere Construction open dumping waste on the property. I went over what I had found during my inspection of the property. We discussed the uses of clean construction or demolition debris in accordance with Illinois Environmental Protection Act: Section 3.160. Construction or demolition debris, (b) clean construction or demolition debris. Mr. Laverdiere was unaware of open dumping taking place on his property. He said he would investigate the allegation and get back to me. Mr. Laverdiere theorized that the anonymous complainant might be the actual open dumper trying to cause his company problems with the Agency.

The following alleged violations were observed and indicated on the open dump inspection checklist:

1. Pursuant to Section 12(a) of the {Illinois} Environmental Protection Act (415 ILCS 5/12(a)), no person shall cause or threaten or allow the discharge of any contaminants into the environment in any State so as to cause or tend to cause water pollution in Illinois, either alone or in combination with the matter from other sources, or so as to violate regulations or standards adopted by the Pollution Control Board under this Act.

A violation of Section 12(a) is alleged for the following reason: John E. Laverdiere and Laverdiere Construction Inc. caused, threatened, or allowed, the discharge of contaminants so as to cause or tend to cause water pollution in Illinois.

Pursuant to Section 12(d) of the {Illinois} Environmental Protection Act (415 ILCS 5/12(d)), no person shall deposit any contaminants upon the land in such place and manner so as to create a water pollution hazard.

A violation of Section 12(d) is alleged for the following reason: John E. Laverdiere and Laverdiere Construction Inc. caused or allowed contaminants to be deposited upon the land in such place and manner so as to create a water pollution hazard.

3. Pursuant to Section 21(a) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(a)), no person shall cause or allow the open dumping of any waste.

A violation of Section 21(a) is alleged for the following reason: John E. Laverdiere and Laverdiere Construction Inc. caused or allowed the open dumping of waste.

4. Pursuant to Section 21(d)(1) of the {Illinois} Environmental Protection Act (415 ILCS 5/21(d)(1)), no person shall conduct any waste-storage, waste-treatment, or waste-disposal operation without a permit granted by the Agency or in violation of any conditions imposed by such permit.

A violation of Section 21(d)(1) is alleged for the following reason: John E. Laverdiere and Laverdiere Construction Inc. conducted a waste-disposal operation without a permit granted by the Agency.
