PETITION FOR REVIEW

1. Emerald Performance Materials LLC (“Petitioner”) hereby petitions the court, pursuant to 415 ILCS 5/41, 35 Ill. Adm. Code 101.906 and Supreme Court Rule 335, for review of the Opinion and Order of the Illinois Pollution Control Board entered on April 16, 2015 in *In the Matter of: Petition of Emerald Performance Materials LLC for an Adjusted Standard from 35 Ill. Adm. Code 304.122(b)*, PCB AS13-2, which granted an adjusted standard to Petitioner subject to certain conditions. Petitioner specifically seeks review and reversal of all or portions of conditions 1, 2.b and 2.h of the Opinion and Order granting the adjusted standard.
