 ILLINOIS POLLUTION CONTROL BOARD
 NOTICE OF PROPOSED SETTLEMENT AND
 PROPOSAL FOR SETTLEMENT OF
 ENFORCEMENT CASE

The Attorney General has brought a case against the Quality Sided Products, LLC, an Illinois based liability company for violation of State pollution control rules. On March 19, 2015, the parties filed a stipulation and proposal for settlement. The parties agree that a hearing is unnecessary, and in accordance with State law, have requested that the settlement be adopted without holding a public hearing. Any person desiring that a hearing be held may demand a public hearing in the case by filing a written hearing request with the Illinois Pollution Control Board within 21 days after the publication of this notice. The hearing request should use: Board of the State of Illinois v. Quality Sided Products, LLC, an Illinois based liability company, POCB 15-172 and should be mailed to the Clerk of the Illinois Pollution Control Board, 100 West Randolph Street, Suite 11-500, Chicago, Illinois 60601.
