The agreement established by Dynegy and the state of Illinois is lacks detail regarding the plan and timeline for installing pollution controls.

The Will County, Powerton and Ed Edwards plants are causing unsafe air in Illinois. As a community member impacted by these sources of pollution, I request that you make these critical improvements to the rule-making to protect my air quality.
