AGREED REQUEST FOR EXTENSION OF TIME TO FILE THE RECORD

NOW COME Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY, by and through the Attorney General of the State of Illinois, *ex rel.* LISA MADIGAN, and Petitioner, WABASH VALLY POWER ASSOCIATION, and pursuant to 35 Ill. Adm. Code 105.116(a), hereby request a 60 day extension of time in which to file the record for this permit appeal. In support of this request, the parties state as follows:

1. By Order of the Board of July 23, 2015, the Respondent was ordered to file the entire administrative record of its determination within 30 days after it was served with the petition. The Respondent was served with the petition on July 20, 2015, and therefore the record was due to be filed by August 19, 2015.

2. On August 18, 2015, the Respondent filed a request for extension of time to file the administrative record. On August 18, 2014, the Board granted Respondent's extension request and set a new administrative record filing date of September 18, 2015.

3. The Petitioner and Respondent continue to discuss the issues presented in the petition and therefore request additional time for this to occur without the administrative record

being filed.

WHEREFORE, Respondent, the Illinois Environmental Protection Agency, and Petitioner, Wabash Valley Power Association, hereby request a 60 day extension of time, until November 17, 2015, for the Respondent to file the administrative record in this matter.
