**NOTICE OF WAIVER OF 120-DAY DECISION DEADLINE**

NOW COMES Petitioner, EXXONMOBIL CORPORATION (“Petitioner”), by and through its attorneys, HODGE DWYER & DRIVER, pursuant to 35 Ill. Admin. Code § 101.308(c)(2), and hereby waives the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board (“Board”) in this proceeding until May 19, 2016. In support of this Notice, Petitioner states as follows:

1. On July 21, 2015, Petitioner filed its Petition for Variance (“Petition”) requesting a variance from the deadline for complying with the chloride standard at 35 Ill. Admin. Code § 302.407(g)(3) for its Joliet Refinery pursuant to the terms and conditions outlined in its Petition.
2. On August 6, 2015, the Board accepted the Petition.
3. The current decision deadline for this matter is April 7, 2016.
4. Petitioner hereby voluntarily agrees to waive the statutory 120-day decision deadline until May 19, 2016.

WHEREFORE, Petitioner, EXXONMOBIL CORPORATION, prays that the Illinois Pollution Control Board accept this waiver of the statutory 120-day decision deadline for final action on Petitioner's Petition for Variance.
