- I am employed by the Illinois Environmental Protection Agency ("Illinois EPA"), as Assistant Counsel for the Bureau of Land.
- 2. As part of my duties, I am responsible for the preparation of Administrative Citations issued by the Illinois EPA and the negotiation and litigation of appeals filed pursuant to such Administrative Citations. As part of my job experience, I have also submitted travel vouchers for reimbursement.
- 3. I have reviewed the Illinois EPA Division of Legal Counsel File 424-14-AC, which relates to AC 15-25, *Illinois EPA v. Mark Bosecker*, for the purpose of determining the costs expended by Illinois EPA.
- 4. I was the Illinois EPA attorney assigned to handle the hearing for AC 15-25, which was held in Mt. Carmel. I was required to travel from Springfield to Mt. Carmel and back. The Illinois Department of Transportation map of the State of Illinois indicates that the distance between Springfield and Mt. Carmel is 214 miles. Because I attended another hearing in Mt. Carmel on the same date, I am not seeking reimbursement for mileage for the return trip. Based on my own job experience, I am aware that the approved mileage reimbursement rate in September 2015 was \$.565 per mile.
