
AMENDED HEARING OFFICER ORDER

 ORIGINAL

On February 25, 2016, a telephonic status conference was held. The petitioner did not appear due to a scheduling conflict. The respondent stated that both parties are in agreement regarding the draft permit but may need to revise a portion of the draft. Discussions now center on whether the revision will affect public notice. To that end, the administrative record is now due to be filed on or before April 15, 2016.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on March 31, 2016, at 11:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




