LIMITED WAIVER OF DECISION DEADLINE

Petitioner Kincaid Generation, L.L.C. (“Kincaid”), by and through its attorneys, SCHIFF HARDIN LLP, pursuant to 35 Ill. Adm. Code 101.308(c)(2), hereby agrees to a limited waiver of the decision deadline for final action by the Illinois Pollution Control Board (“Board”) in this proceeding through July 21, 2016. In support of this waiver, Petitioner states as follows:

1. On June 5, 2015 Petitioner filed a petition for review of National Pollutant Discharge Elimination System (“NPDES”) permit dated April 30, 2015 for the Kincaid Generating Station, challenging certain conditions of the permit.
2. The current decision deadline for this matter is June 2, 2016.
3. Petitioner hereby voluntarily agrees to a limited waiver of the decision deadline through July 21, 2016.
