On July 7, 2016, the parties informed the hearing officer that Kincaid Generation awaits the issuance of the permit and is optimistic that it will be issued soon. Kincaid Generation stated that it will file an additional 30-day waiver of the statutory decision deadline.

By agreement, the administrative record is now due to be filed on or before August 31, 2016.

At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
