

WITHDRAW ADMINISTRATIVE CITATION



Ryan, pursuant to Section 101.500 of the Illinois Pollution Control Board's ("Board") Rules and Regulations, 35 Ill. Adm. Code 101.500, , and respectfully states as follows:

1. In March 2015, the Illinois EPA served the Respondents with Administrative Citation No. 75-15-AC.
2. On or about April 13 and May 4, 2015, Respondents Cain and Jones, respectively, filed Petitions for Review contesting the administrative citation.
3. Based upon facts and circumstances discovered since the filing of the Administrative Citation, Illinois EPA has determined that it is prudent to withdraw this Administrative Citation at this time.
