
HEARING OFFICER ORDER

On August 18, 2016, the complainant informed the hearing officer that the respondent has failed to review and sign the stipulation and proposal for settlement (stipulation) that was forwarded to him in April 2016. The complainant will attempt to contact the respondent prior to the next status conference.

The parties are encouraged to consent to receive e-mail service of my orders. Consent may be mailed and need only include a name, e-mail address and reference to this docket number.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on September 7, 2016, at 9:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the status conference the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation is filed prior to the next status conference, the status will be cancelled without further notice.

IT IS SO ORDERED.




