Good afternoon. Our responses appear in bold font following your inquiries, which I have repeated for convenience:

Sec. 307.4503(c)(1), 2<sup>nd</sup> line (line 667): Would it be possible to add dates to these CFR references?

**Yes, the date "(2016)" will be added. Same change will be made at line 729.**

Sec. 307.4503(c)(1)(B)(iv), 3<sup>rd</sup> line (line 697): Should "scales particles" be "scale particles"?

**Yes, will be changed.**

Regarding CFR incorporations: Do you want to add a general incorporation by reference section to this Part, or would you prefer to individually add dates throughout?

**I'm afraid that a centralized section for incorporations by reference would be counter-productive in this instance. Scattered throughout Part 307 are some 1,750 incorporations by reference. Having all of those in one section would prove unwieldy.**

"This statement fulfills USEPA's intent" → Why use "fulfills" rather than (for example) "reflects"?

**Your question has caused us to consider simplifying the provisions at 307.4503(c)(2), 307.4503(d)(2), and 307.4508. We are working on potential rule language plainly identifying the Board pretreatment standards that do not apply to the given types of facilities.**
