MOTION FOR EXTENSION OF HEARING DATE

Respondent, Midwest Generation, LLC, ("MWG") by and through counsel, requests that the Illinois Pollution Control Board ("Board") enter an order extending the Hearing Date for the above captioned matter. In support of its motion, Respondent states the following:

- 1. On February 9, 2017, the Hearing Officer set the hearing dates for July 17 through 21, 2017.
- 2. Pursuant to Board Rule 101.522, the Board or Hearing Officer may extend the time for any act for good cause shown on a motion and after notice to the opposite party.
- 3. Following scheduling of the Hearing, MWG's in-house counsel found that he is unavailable to assist or participate in the hearing on the scheduled dates.
