**HEARING OFFICER ORDER**

On August 17, 2017, the parties participated in a telephone status conference with the hearing officer. The Title V permit is almost ready for public notice, and should be issued by the end of the year. Respondent and USEPA plan to meet by the end of September to discuss the waste analysis plan, and other issues related to the RCRA permit. Respondent's technical unit and management continue to discuss the RCRA permit, including whether additional risk assessment is needed. The retirement of key personnel in the technical unit has caused delays.

The parties are directed to participate in a telephone status conference with the hearing officer at 10:00 a.m. on October 5, 2017. The status conference shall be initiated by the petitioner.

The parties consent to electronic service, and petitioner has filed an open waiver of the decision deadline.
