NOTICE OF HEARING**

The Illinois Pollution Control Board gives notice of public hearings regarding rule changes proposed by the Illinois Environmental Protection Agency (IEPA) on February 22, 2018: In the Matter of Amendment to 35 Ill. Adm. Code 205, Emissions Reduction Market System, R18-22.

If adopted by the Board, the IEPA will submit this rule to the United States Environmental Protection Agency (USEPA) for review and approval as a revision to the ozone portion of the Illinois State Implementation Plan (SIP). The revisions submitted to USEPA will consist of 35 Ill. Adm. Code 205.115, which sunsets the Emissions Reduction Market System program, as well as an analysis demonstrating that the proposal does not interfere with attainment or maintenance of any applicable National Ambient Air Quality Standard, reasonable further progress, or any other applicable requirement of the Clean Air Act (CAA). This notice is intended to satisfy the requirements of Section 110(1) of the CAA, 42 U.S.C. § 7410(1) (public notice for SIP revisions).

Interested persons are invited to attend the hearings and to submit written comments. The public hearings will be held by videoconference on Thursday, May 10, 2018, at 9:00 AM and on Thursday, June 7, 2018, at 9:00 AM in Room 11-512 of the James R. Thompson Center, 100 West Randolph Street, Chicago, Illinois and the Illinois Pollution Control Board Conference Room 1244 N at 1021 North Grand Avenue East, North Entrance, in Springfield, Illinois.

The hearings are subject to cancellation without notice and may be confirmed by calling the Office of the Board's Clerk at 312-814-3461. A copy of the proposal for public comment is available for public inspection on the Board's website <http://www.ipcb.state.il.us> and in the Clerk's Office of the Illinois Pollution Control Board, Suite 11-500, James R.
