NOTICE OF PUBLIC INFORMATION ON PROPOSED AMENDMENT

Notice of Public Hearing for State Implementation Plan (SIP) Submissions for National Ambient Air Quality Standards (NAAQS)

On February 22, 2018, the Illinois Environmental Protection Agency (IEPA) proposed that the Board amend Part 205 of the Board's air pollution regulations by setting a sunset date of April 30, 2018, for the Emissions Reduction Market System (ERMS). *See* In the Matter of:

Amendment to 35 Ill. Adm. Code 205, Emissions Reduction Market System, R 18-22 (Mar. 22, 2018) (Accepting proposal for hearing). The full text of this proposed rulemaking is available for public review under the docket number R 18-22 on the Board's website (www.ipcb.stste.il.us) and in the Clerk's Office of the Illinois Pollution Control Board, Suite 11-500, James R. Thompson Center, 100 West Randolph Street, Chicago, Illinois.

If adopted by the Board, the IEPA will submit this rule to the United States Environmental Protection Agency (USEPA) for review and approval as a revision to the ozone portion of the Illinois State Implementation Plan (SIP). The revisions submitted to USEPA will consist of 35 Ill. Adm. Code 205.115, which sunsets the Emissions Reduction Market System program, as well as an analysis demonstrating that the proposal does not interfere with attainment or maintenance of any applicable National Ambient Air Quality Standard, reasonable further progress, or any other applicable requirement of the Clean Air Act (CAA). This notice is intended to satisfy the requirements of Section 110(1) of the CAA, 42 U.S.C. § 7410(1) (public notice for SIP revisions).

The proposed revision to the SIP will be discussed at public hearings that will be held by videoconference on Thursday, May 10, 2018, at 9:00 AM and on Thursday, June 7, 2018, at 9:00 AM in Room 11-512 of the James R. Thompson Center, 100 West Randolph Street, Chicago, Illinois and the Illinois Pollution Control Board Conference Room 1244 N at 1021 North Grand Avenue East, North Entrance, in Springfield, Illinois. Interested persons are invited to attend and express their views.
