<u>AC 19-1</u>	<u>IEPA v. William and Rose Robinson (Land)</u> – The Board found that respondents had violated Sections 21(p)(1), 21(p)(3), 21(p)(7), and 55(k)(1) of the Environmental Protection Act (415 ILCS 5/21(p)(1), 21(p)(3), 21(p)(7), and 55(k)(1) (2016)). Because there were three violations of Section 21(p) and one of 55(k), the Board ordered respondents to pay a civil penalty of \$6,000.	5-0

<u>PCB 12-35</u>	<u>People of the State of Illinois v. Six M. Corporation, Inc., an Illinois corporation, William Maxwell, and Marilyn Maxwell, and Joinder of James McIlvain as Necessary Party (Air – Enforcement)</u> – The Board reserved ruling on the People’s motion for permission to file a first amended complaint pending complainant’s filing proof of service and proper notice on all respondents.	5-0
<u>PCB 18-80</u>	<u>Phillips 66 Company v. IEPA (UST Appeal)</u> – Having previously granted a request for a 90-day extension, the Board dismissed this matter because no underground storage tank appeal was filed on behalf of this Lake County facility.	5-0
<u>PCB 18-84</u>	<u>James Fiser v. Henry's Double K, LLC, and James L. Meador (Noise – Enforcement, Citizens)</u> – The Board denied respondents’ motion to dismiss and, finding the complaint neither duplicative nor frivolous, accepted the complaint for hearing. The Board also directed respondents to answer the complaint by November 5, 2018, directed complainant’s attorney to file an appearance by September 27, 2018, and directed respondent Henry’s Double K, LLC to file an appearance by an attorney at or before the time it answers the complaint.	5-0
<u>PCB 19-2</u>	<u>Reliable Stores, Inc. v. Office of State Fire Marshal (UST Appeal)</u> – The Board accepted for hearing this underground storage tank appeal involving a site in Cook County.	5-0

<u>PCB 19-53</u>	<u>Evelyn M. Page Trust, Wayne A. Page and Kennard Page, Successor Trustees v. IEPA (UST Appeal)</u> – The Board accepted for hearing this underground storage tank appeal involving a site in Peoria County.	5-0
