


MOTION TO VOLUNTARILY DISMISS ADMINISTRATIVE CITATION

NOW COMES the Complainant, the Illinois Environmental Protection Agency (“Illinois EPA”), by and through its attorney, Assistant Counsel Jacob H. Smith, pursuant to 35 Ill. Adm. Code 108.402, and respectfully states as follows:

1. On October 9, 2018, the Illinois EPA issued an Administrative Citation to Respondent Walter Willing, based on a Records Review Memorandum conducted on October 2, 2018.
2. On October 9, 2017, the Administrative Citation that was issued to the Respondent was concurrently filed electronically with the Illinois Pollution Control Board.
3. Since the filing of this administrative citation, the Illinois EPA and the Respondent have resolved this matter. Accordingly, the Illinois EPA voluntarily moves that this Administrative Citation should be dismissed.

WHEREFORE, the Illinois EPA requests that the Board dismiss the pending action.
