

DISMISS ADMINISTRATIVE CITATION


NOW COMES the Complainant, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY (“Illinois EPA”), by and through its attorney, Michelle M. Ryan, pursuant to Section 101.500 of the Illinois Pollution Control Board’s (“Board”) Rules and Regulations, 35 Ill. Adm. Code 101.500, and respectfully states as follows:

1. In September 2018, the Illinois EPA served the above-named Respondent with Administrative Citation No. 124-18-AC.
2. In October 2018, Respondent filed a Petition for Review contesting the Administrative Citation.
3. Based upon information obtained since the filing of the Administrative Citation, Illinois EPA has determined that Brent A. Ludwig Estate is not the owner of the property at issue in this Administrative Citation, and therefore the Administrative Citation should be dismissed.

WHEREFORE, the Illinois Environmental Protection Agency requests that the Board dismiss the pending action against Respondent.


