


NOW COMES the Complainant, the Illinois Environmental Protection Agency (“Illinois EPA”), by and through its attorney, Michelle M. Ryan, pursuant to 35 Ill. Adm. Code 108.402, and respectfully states as follows:

- (1) On January 2, 2019, Illinois EPA issued an Administrative Citation to Respondents Tyler Ferguson, Bradon Finch, Carl Lee, and James Hilton based on an inspection conducted on November 8, 2018.
- (2) Service was had on Respondent Bradon Finch on January 7, 2019.
- (3) Proof of service is not available for Respondents Tyler Ferguson, Carl Lee, and James Hilton.
- (4) Because Illinois EPA cannot demonstrate that Respondents Tyler Ferguson, Carl Lee, and James Hilton were timely served within 60 days as required by 415 ILCS 5/31.1(b), this Administrative Citation should be dismissed as to those Respondents.

WHEREFORE, the Illinois Environmental Protection Agency requests that the Board dismiss the pending action as to Respondents Tyler Ferguson, Carl Lee, and James Hilton.




