RECOMMENDATION**

Pursuant to 35 111. Adm. Code 104.220, Petitioner VILLAGE OF CRESTWOOD ("Crestwood") submits the following Response to the Recommendation of Illinois Environmental Protection Agency ("Recommendation") to the Illinois Pollution Control Board ("PCB") filed on April 5, 2019 regarding Crestwood's Petition (PCB 19-40) for Chloride Time-Limited Water Quality Standard ("TLWQS") for the Defined Chicago Waterway System/Des Plaines River Watershed.

Rather than repeat the responses that have already been filed, Crestwood joins in, adopts, and incorporates into its Response the suggestions, concerns, and requests for clarifications as contained in the responses filed by the City of Oak Forest (PCB 16-33); Village of Orland Park (PCB 16-15); Village of New Lenox (PCB 19-4); Village of Glenwood (PCB 19-26); Village of Midlothian (PCB 16-16); City of Crest Hill (PCB 19-12) and the City of Lockport (PCB 19-10)

In addition, Crestwood joins in, adopts, and incorporates into its Response the suggestions, concerns, and requests for clarifications contained in the Response that will be filed by the Metropolitan Water Reclamation District of Greater Chicago ("MWRDGC") (PCB 16-29).

Crestwood specifically agrees with the IEPA's recommendation that at least 15 years will be necessary for the benefits of the adaptive management approach to be measureable in the water bodies.
