New liners were installed in the Waukegan ash ponds in 2003(east) and 2005(west) in accordance with current industry standards.

The liner material is 60 mil HDPE, with a density of no less than 0.94 g/cm3. The pond floors are lined with a 12 inch layer of sand, capped by a 6 inch layer of limestone screenings. These liners are inspected on an annual basis to ensure continuing integrity.
