Re: Compliance Commitment Agreement - Well Installation Documentation Midwest Generation, LLC, Waukegan Station; ID No. 6281 Violation Notice W-2012-00056

Dear Ms. Rhodes:

The Compliance Commitment Agreement (CCA) for the above referenced site relative to Violation Notice W-2012-00056 was signed by Midwest Generation on October 15, 2012 and executed by Illinois Environmental Protection Agency (IEPA) signature on October 24, 2012 (effective date). Item 5 (d) of the CCA requires Midwest Generation to install two additional groundwater monitoring wells at locations approved by IEPA, within 90 days of the effective date of the CCA.

Mr. Lynn Dunaway of IEPA was invited to a field meeting to site the well locations, however, rather than attending, he verbally approved the general locations based on the attached Figure 1. On November 6, 2012, Midwest Generation and KPRG and Associates, Inc. (KPRG) met in the field to locate the proposed well locations (labeled as well MW-6 and MW-7 on Figure 1). KPRG installed the monitoring wells on November 19, 2012 and developed the wells on November 27, 2012. Attached are the boring logs/well construction summaries for the new wells. The wells were included in the quarterly groundwater monitoring performed in December 2012.

This submittal fulfills the requirements set forth under Item 5 (d) of the signed CCA. Please call me at 630-771-7863 if there are any questions.




