As I mentioned, second notice in docket R18-17 is on the agenda for tomorrow's Board meeting. Below, you'll find our responses (in bold font) to your additional questions, which are repeated for your convenience.

Part 602:

1. In line 697, our version misspells "community".

Accept corrected spelling.

2. For flooding estimates, why provide the option of 100 vs. 500 year flood projections rather than requiring both?

Under Section 602.245(d)(2), plans in a permit application for constructing a surface water intake—at a site subject to flooding—must specify the maximum flood level based on the best available information. That information must include the flood of record, the projected 100-year flood, or the projected 500-year flood. Allowing these alternatives gives the applicant flexibility, but any one of them will suffice.
