# PLAINTIFF'S MOTION FOR VOLUNTARY DISMISSAL OF COUNT IV OF COMPLAINANT'S AMENDED COMPLAINT WITHOUT PREJUDICE

NOW COMES Complainant, PEOPLE OF THE STATE OF ILLINOIS, by KWAME RAOUL, Attorney General of the State of Illinois ("Complainant"), and hereby moves, pursuant to Section 2-1009 of the Illinois Code of Civil Procedure, 735 ILCS 5/2-1009, and Section 101.500 of the Illinois Pollution Control Board ("Board") regulations, 35 Ill. Adm. Code 101.500, the Board to dismiss Count IV of Complainant's Amended Complaint without prejudice. In support of its Motion, Complainant states as follows:

- On April 22, 2010, Complainant filed a Complaint in the above-referenced matter.
   Complainant filed a Motion for Leave to File Amended Complaint on April 10, 2013. On
   May 16, 2013, the Board issued an Order accepting the Amended Complaint.
- 2. On January 21, 2015, Complainant filed its Motion for Summary Judgment on Counts I, II, III and V of its Amended Complaint.

- 3. Since Count IV was brought in the alternative to Count III, Complainant did not include it in the initial Motion for Summary Judgment.
- 4. On November 2, 2015, Complainant filed a Motion to Stay Proceedings due to potential settlement with Cheyenne Resources, Inc.
- 5. On December 22, 2017, Complainant filed a Motion for Joinder joining Cheyenne Resources, Inc. and a Stipulation for Settlement settling Counts I and II of the Amended Complaint. Subsequently, the Board granted the Motion for Joinder on January 11, 2018, and entered the order for stipulation and settlement on February 22, 2018.
- 6. On January 11, 2018, the Board lifted the stay on the Motion for Summary Judgment against Respondent Illinois Fuel Company, LLC.
- 7. On July 25, 2019, the Illinois Pollution Control Board granted Complainant's unopposed Motion for Summary Judgment on Counts III and V of the Amended Complaint.
- 8. Section 2-1009(a) of the Illinois Code of Civil Procedure, 735 ILCS 5/2-1009(a), provides as follows:

The plaintiff may, at any time before trial or hearing begins, upon notice to each party who has appeared or each party's attorney, and upon payment of costs, dismiss his or her action or any part thereof as to any defendant, without prejudice, by order filed in the cause.

- 9. As this matter has not yet reached hearing on Count IV, the Board having ruled in Complainant's favor on Count III, Complainant is authorized by 735 ILCS 5/2-1009(a) to dismiss Count IV without prejudice.
- 10. Section 5-117 of the Illinois Code of Civil Procedure, 735 ILCS 5/5-117, provides, in relevant part, as follows:

In all actions commenced for and on behalf of the people of this state...if the action is dismissed voluntarily by the

plaintiff...the defendant shall not recover any costs whatsoever.

11. As required by the plain language of 735 ILCS 5/5-117, the Complainant requests that Count IV be dismissed without prejudice, with both parties to each bear their own costs.

WHEREFORE, Complainant, PEOPLE OF THE STATE OF ILLINOIS, by KWAME RAOUL, Attorney General of the State of Illinois, respectively requests that the Board enter an order dismissing Count IV of Complainant's Amended Complaint without prejudice, with both parties to each bear their own costs.
