

HEARING OFFICER ORDER

On August 27, 2019, all parties participated in a telephonic status conference call with the hearing officer. Discussions centered on the Board's order of July 25, 2019, directing the respondent to file its recommendation by September 9, 2019, and consolidating this case with PCB 16-24 for purposes of hearing. Midwest Generation, LLC, v. IEPA, PCB 16-19 (July 25, 2019). The respondent indicated that it may file a motion for extension of time.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on September 19, 2019, at 11:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




