HEARING OFFICER ORDER

On July 25, 2019, the Board set a deadline of September 9, 2019 for the Illinois Environmental Protection Agency (IEPA) to file its recommendation in this petition for time-limited water quality standard.

On September 9, 2019, the IEPA, Midwest Generation, LLC. (MWGen), and INEOS Joliet, LLC. (INEOS) filed a joint motion for an extension of IEPA's deadline to file a recommendation (Mot.) to December 9, 2019.


IEPA reports that it "has been diligently working on its recommendation," but requires additional time to discuss specified issues with the United States Environmental Protection Agency (USEPA) and INEOS. Mot. at 2. IEPA's recommendation on MWGen's petition also depends on the results of these discussions with the USEPA. Id. at 4.

Note that the Board's order July 25, 2019 consolidated this petition with PCB 16-19 for purposes of the hearing. INEOS Joliet, LLC, v. IEPA, PCB 16-24 (July 25, 2019).

The joint motion for an extension is granted, and the IEPA is directed to file its recommendation on or before December 9, 2019.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on September 19, 2019, at 10:30 a.m. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


