ILLINOIS EPA'S MOTION FOR JUDICIAL ENFORCEMENT OF SUBPOENA DUCES TECUM

NOW COMES the ILLINOIS ENVIRONMENTAL PROTECTION AGENCY ("Illinois EPA"), by and through its counsel, and for its Motion for Judicial Enforcement of Subpoena Duces Tecum states as follows:

- 1. On December 19, 2019, the Illinois EPA served a subpoena for documents on Amy Harding ("Harding"), the corporate controller for Emerald Performance Materials, LLC.
- 2. Because of the joint accounting practices of Petitioner and Emerald Performance Materials, LLC, Harding was to provide the Illinois EPA with Emerald Performance Materials, LLC's balance sheet(s) for fiscal years 2015-2019; income statement(s) for fiscal years 2015-2019; cash flow statement(s) for fiscal years 2015-2019; and annual audits for fiscal years 2015-2019, on or before January 3, 2020.
- 3. During Harding's deposition in this case, Harding disclosed this information was readily available and could be provided.
 - 4. To date, this information has not been provided to the Illinois EPA.
- 5. 35 Ill. Adm. Code 101.622 provides that the failure of any witness to comply with a subpoena will subject the witness to sanctions or the judicial enforcement of the subpoena.
- 6. Further, Section 101.622 provides that the Board may, upon proper motion by the party requesting the subpoena, request the Attorney General to pursue judicial enforcement of the

subpoena on behalf of the Board.

7. In this case, the Board should request representation from the Attorney General's

Office and request that the Attorney General seek enforcement of the subpoena under Washington

State's Uniform Interstate Depositions and Discovery Act. 5.51 RCW.

Attorney General's Office and undersigned has confirmed the request for representation and
