PUBLIC NOTICE

On December 30, 2019, Midwest Generation, LLC filed a Petition to Approve Thermal Effluent Limitations with the Illinois Pollution Control Board. Midwest Generation is seeking alternative effluent limitations for its Joliet 9 Generating Station located in Will County, near Joliet, Illinois, pursuant to 35 Ill. Adm. Code § 304.141(c), Section 316 (a) of the Clean Water Act and 35 Ill. Adm. Code Part 106, Subpart K. Joliet 9 Generating Station produces electricity. For cooling purposes, the facility draws water from the Upper Dresden Island Pool (a segment of the Lower Des Plaines River), uses it to absorb heat, and then discharges the heated water back into the pool. Midwest Generation, LLC is seeking alternate thermal limitations in lieu of the limitations set forth in 35 Ill. Adm. Code §§ 302.408(c)-(f), (i). Specifically, Midwest Generation, LLC requests the following alternate limitations: The daily maximum temperature of the Joliet 9 Generating Station's discharge shall not exceed 65°F in January or February; 70°F in March; 80°F in

April; 85°F in May; 93°F in June, July, August, or September; 90°F in October; 85°F in November; or 70°F in December, for more than 5% of the time in a calendar year. At no time shall the water temperature exceed the maximum limit by more than 1.7°C (3°F).

The segment of the Lower Des Plaines River immediately downstream from the Upper Dresden Island Pool is commonly known as the "Five-Mile Stretch." It runs from I-55 Bridge (River Mile 277.9) to the headwaters of the Illinois River (River Mile 273.0). Although the Joliet 9 Generating Station does not discharge into this waterbody, its discharges can influence this downstream segment. In addition to the relief sought above, Midwest Generation LLC is seeking alternate thermal limitations in lieu of those set forth in 35 Ill. Adm. Code §§ 302.211(b)-(e). Specifically, Midwest Generation, LLC requests the following alternate limitations: The daily maximum temperature of the Joliet 9 Generating Station's discharge shall not exceed 60°F in January or February; 65°F in March; 73°F in April; 85°F in May; 90°F in June; 91°F in July or August; 90°F in September; 85°F in October; 75°F in November; or 65°F in December; for more than 5% of the time in a calendar year. At no time shall the water temperature exceed the maximum limit by more than 1.7°C (3°F).

Midwest Generation, LLC is located at 440 South LaSalle Street, Suite 3500, Chicago, Illinois. Any person may cause a public hearing to be held in the above-described proceeding by filing a hearing request with the Illinois Pollution Control Board within 21 days after the date of the publication of this notice. The hearing request should clearly indicate the docket number for the proceeding (PCB 2020-038), and be filed with the Clerk of the Board, Illinois Pollution Control Board, 100 W.
