#### ADMINISTRATIVE CITATION

NOW COMES the Complainant, County of Jackson, by and through the Jackson County State's Attorney, with this Administrative Citation against the Respondents, NORMAN MARTIE and MONICA MARTIE, alleging as follows:

#### **JURISDICTION**

This Administrative Citation is issued pursuant to authority vested in the Illinois Environmental Protection Agency by 415 ILCS 5/1 et. seq., specifically 415 ILCS 5/31.1.

#### **FACTS**

- 1. The Respondents, Norman Martie and Monica Martie, are the present owners, occupants and in control and possession of a facility located in the County of Jackson, State of Illinois.
- 2. The facility is an open dump, operating without an Illinois Environmental Protection Agency Operating Permit, and designated with the Site Code 077 810 5103. The facility is known to the Agency as the Murphysboro/Norman & Monica Martie site.
- 3. The Respondents have owned, occupied, controlled and/or operated the facility at all material times hereto.

- 4. On December 20, 2019, Deborah Johnson, Environmental Compliance Inspector, Jackson County Health Department, inspected the facility. A true and correct copy of her Affidavit, along with her inspection report, are attached and incorporated herein by reference as Exhibit A.
- 5. Previously, on October 19, 2018, an Administrative Citation Warning Notice ["ACWN"] was issued to Norman and Monica Martie for open burning and open dumping apparent violations.
- 6. Subsequently, a Continuing Violation Notice ["CVN"] was issued on February 13, 2019.
- 7. On May 15, 2019, an ACWN was issued to the same individuals for the same address.
- 8. On July 12, 2019, another CVN was issued to the same Respondents.

#### **VIOLATIONS**

The facility was most recently inspected on December 20, 2019. Based on Environmental Compliance Inspector Deborah Johnson's direct observations, she has determined the Respondent has caused or allowed open dumping at the above described facility in a manner that resulted in the following violations:

- A. The Respondents have caused or allowed litter at the facility, in violation of 415 ILCS 5/21(p)(1).
- B. The Respondents have caused or allowed open burning at the facility, in violation of 415 ILCS 5/21(p)(3).
- C. The Respondents have caused or allowed the deposit of general or clean construction or demolition debris at the facility, in violation of 415 ILCS 5/21(p)(7).

#### CIVIL PENALTY

Pursuant to Section 42(b)(4-5) of the Act, 415 ILCS 5/42(b)(4-5), Respondents are subject to a civil penalty of One Thousand Five Hundred Dollars (\$1,500.00) for each of the violations identified above, for a total of <u>FOUR THOUSAND FIVE HUNDRED</u> (\$4,500.00). If Respondents elect not to petition the Illinois Pollution Control Board, the statutory civil penalty specified above shall be due and payable no later than thirty (30) days from the date that you are served with this document, unless otherwise provided by order of the Illinois Pollution Control Board.

If Respondents elect to contest this Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1, and if the Illinois Pollution Control Board issues a finding of violation as alleged herein, after an adjudicatory hearing, Respondent shall be assessed the associated hearing costs incurred by the Illinois Environmental Protection Agency and the Illinois Pollution Control Board. Those hearing costs shall be assessed in addition to the Fifteen Hundred Dollars (\$1,500.00) statutory civil penalty for each violation.

Pursuant to Section 31.1(d)(1) of the Act, 415 ILCS 5/31.1(d)(1), if Respondent fails to petition or elects not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and findings of violation as alleged herein, and shall impose the statutory civil penalty specified above.

When payment is made, checks shall be made payable in equal amounts (50% of the total penalty each) to:

- County of Jackson, c/o Jackson County Treasurer, Jackson County Courthouse,
   Murphysboro, Illinois 62966; and
- (2) Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276.

Respondent shall complete and return the enclosed Remittance Forms with payments to ensure proper documentation of payment. If any civil penalty and/or hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs shall be assessed against the Respondent from the date payment is due up to and including the date that payment is received. The Complainant may either initiate proceedings against the Respondent in Circuit Court or other debt collection actions to collect said penalty and/or hearing costs, plus any interest accrued.

#### PROCEDURE FOR CONTESTING ADMINISTRATIVE CITATION

You have the right to contest this Citation, pursuant to 415 ILCS 5/31.1. If you elect to contest this Citation, you must file a Petition For Review with the Clerk of the Illinois Pollution Control Board. A copy of the Petition For Review shall also be filed with the Jackson County State's Attorney. The mailing addresses are noted below.

YOUR PETITION FOR REVIEW MUST BE FILED WITHIN 35 DAYS OF THE DATE OF SERVICE OF THE PRESENT CITATION ON YOU.

YOUR PETITION MUST STATE THE REASON(S) YOU BELIEVE THE PRESENT MATTER SHOULD NOT BE ISSUED. IF YOU FAIL TO FILE YOUR PETITION AND STATE THE REASONS THE PRESENT MATER SHOULD NOT BE ISSUED, A DEFAULT ORDER AGAINST YOU WILL BE ENTERED BY THE POLLUTION CONTROL BOARD.

#### **Executive Summary**

Pursuant to a complaint received at the Jackson County Health Department (JCHD) alleging open burning at this site, I conducted a follow up inspection on December 20, 2019. Brittany Jones of JCHD accompanied during the inspection. The complaint was valid, and I observed evidence of open burning.

The original inspection of this site was pursuant to an open burning complaint. An Administrative Citation Warning Notice (ACWN) was issued to Norman and Monica Martie on October 19, 2018 for open burning and open dumping apparent violations. Subsequently, a Continuing Violation Notice (CVN) was issued on February 13, 2019, another ACWN on May 15, 2019, and another CVN on July 12, 2019. During the July 12, 2019 inspection, I noticed a large portion of the open dumped items had been removed and the front yard was mostly cleaned-up. However, as of December 20, 2019 inspection, Mr. and Ms. Martie had not fully complied with the CVN issued on July 12, 2019, and during the follow-up inspection, I observed evidence of open burning in the front yard and continuing open dumping of waste in the backyard.

#### **Evaluation Narrative**

Upon arrival, I started the inspection by photographing the burn location in the front yard (Photo 1). Adjacent to the burn location, and among metal drums and a metal trash can, were charred remains of waste metal items, a fabric chair, plastic items and cardboard. Photo 2 shows packaging material inside one of the metal drums. I then went to the residence. No one answered the knock at the door. From this location, I photographed a close-up of the recent burn pile (Photo 3) and an overview of the burn location (Photo 4). The burn pile consisted of charred dimensional lumber, hose, various types of wire, and landscape waste. Also, on the ground were waste chair components, wooden boards, a hose, and a wooded drawer with charred metal cans inside of it.

In the back portion of the property, I noticed that the majority of the open dumped waste was still in the back yard and was moved into a central location (Photo 5). The open dumped waste included, but was not limited to: fabric couch/chair, carpet, used waste tire, wooden boards and dimensional lumber, various metal and plastic items, electronics, landscape waste, and items not readily identifiable. Photo 6 shows the dilapidated building at the northeast corner of the property. Before I left the backyard, I noted that most of the waste against the residence had been removed from that location (Photo 7).

As of this report, I have not received any recycling and/or waste disposal receipts. Waste material listed in this narrative were not in use, were not usable in their current condition and/or were not stored in a manner to protect the material for future use.

According to the Jackson County Assessor's Office online records, the real estate tax bill for this property is sent to Mr. Norman Martie located at the site address. The parcel number is 14-15-301-003.







