Reg. 50978 (Oct. 9, 1991)), as reflected in the Illinois statutory definitions of "lateral expansion," "existing MSWLF unit," and "new MSWLF unit," (415 ILCS 5/3.275 and 3.285 (2018)), adopted by the Board in RCRA Subtitle D Amendments (Amendments to 35 Ill. Adm. Code 810, 811, and 814), R93-10 (Sep. 15, 1993), by IIS rulemaking under sections 7.2 and 22.40(a) of the Act (415 ILCS 5/7.2 and 22.40(a) (2018)).

<u>Continuing Function of the Date:</u> As long as any landfill unit that received household waste before October 9, 1993 continues to operate at any stage, from receiving waste through their post-closure care periods, the date is needed to distinguish those units.

<u>Limitations on Removal:</u> Aside from any continuing function, there may no reason to retain this date or the distinctions between "existing MSWLF unit" and "new MSWLF unit." Such a change, however, would take extensive deliberation and work to ensure there is no reliance on the definitions in any of 35 Ill. Adm. Code 810, 811, and 814. The Board may remove by IIS rulemaking.
