HEARING OFFICER ORDER

On August 20, 2020, all parties participated in a telephonic status conference with the hearing officer. The parties appear to agree that the last testing report regarding the dust collector at issue found that the noise level was acceptable and below standards. Complainant stated, however, that it may not be conclusive. Complainant also expressed concern about past violations and how they can be remedied. I have provided a similar Board case, PCB 05-93, as a starting point for settlement discussions. Discussion was also entertained about a motion for summary judgment that respondent may file.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on September 29, at 10:30 a.m. The telephonic status conference must be initiated by the complainant, including a call-in number, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
