On December 19, 2019, the board proposed amendments to update the Definition of Class 4 Etiologic Agent. On September 16, 2020, the hearing officer directed participants intending to testify at this hearing to pre-file all of their testimony by September 24, 2020. The board has received no pre-filed testimony.
